On the above date at approximately 0311 hours, I was dispatched to the Loxahatchee Club Guardhouse located at 1010 Loxahatchee Club Drive in the Town of Jupiter, Palm Beach County, Florida, in reference to an impaired driver. Loxahatchee Club Security Guard Thomas Johnson advised a female later identified as Casey Stowe was at the guardhouse in a white Hyundai Genesis and appeared to be drunk. Security advised Jupiter Police Dispatch Stowe was trying to leave and they were trying to keep her there. As I arrived, I saw Stowe leaving in her car. She turned west on Toney Penna Drive. I saw the security guards pointing at her vehicle as it left and saw no other vehicles at the guardhouse. The vehicle was driving very slowly. It turned onto Pinetree Trail and I initiated a traffic stop based on the citizen informant's statements about the crime in progress made to Jupiter Police Dispatch and relayed to me. I walked up to the driver's side door and spoke to the driver, identified to me as Casey Stowe. Stowe had blood shot, glassy eyes and slurred speech. Stowe denied that any kind of confrontation occurred at the guardhouse. Stowe had great difficulty answering simple questions and trailed off while speaking often. Stowe declined medical attention. I could smell a very strong odor of an unknown alcoholic beverage on Stowe's breath. Stowe's movements were slow. Stowe appeared to have poor coordination and difficulty concentrating in general. When I asked Stowe where she lived, Stowe stated a phone number instead. I set up a nearby area to complete roadside tasks. I then asked Stowe to exit her vehicle. Stowe was reluctant to do so and argued with me. Stowe eventually exited the vehicle. I asked her to walk to the front of my car. Stowe stumbled as she walked to the front of my car. I asked Stowe if she felt sure she was OK to drive. Stowe thought

for a minute then said, "No." I asked Stowe how intoxicated she felt on a scale of 1-10. Stowe said, "One." When I pointed out the obvious contradiction in the consecutive statements, Stowe did not respond directly but instead stated she wanted to go back to her car. I told her she couldn't. Stowe attempted to walk back to her car, nearly walking into the path of an oncoming car in the process. I grabbed her arm to stop her and told her I would not let her go back to her car and she had to stay where we were. I then asked Stowe to complete roadside tasks and advised her of her Taylor Warnings simultaneously so there was no confusion about the tasks being compulsory. Stowe refused. I started to try to explain the tasks to Stowe so she knew what she was refusing. Stowe became completely intransigent and spoke over me repeatedly, insisting she was refusing.

I then placed Stowe under arrest. She tensed and pulled away as Officer McGillicuddy and I attempted to handcuff Stowe. After securing Stowe in handcuffs, which I checked for spacing and double locked, I walked her back to my vehicle. I sat Stowe in the back of my car. Upon the arrival of Officer Raleigh I had Stowe exit the vehicle for a full search incident to arrest. Upon completion, Stowe again refused to get back in my car. Officer Raleigh and I had to direct Stowe to sit back down by pushing her hips.

I then transported Stowe to the Palm Beach County Breath Alcohol Testing Facility. During transport, Stowe asked the same few questions over and over again, had several mood swings, and slurred several insults at me. Stowe asked me many times (apparently without any self-awareness whatsoever) if she was being arrested for DUI.

Upon arrival at the Breath Alcohol Testing Center, I conducted a 20 minute observation period facing Stowe. I then asked Stowe to provide a sample of her breath. Stowe refused. I read Implied Consent from a prepared text. Stowe repeated several times she was refusing. Stowe stated she didn't understand Implied Consent. I started reading it again, with the intent of checking for understanding after each sentence. Stowe spoke over me repeatedly and said she was refusing. Stowe refused to engage in any conversation about what she did not understand. I warned Stowe that I would not assist her any further in understanding Implied Consent. Stowe remained belligerent and uncooperative. I took this as a refusal.

I then secured Stowe in a holding cell while I completed my paperwork. Stowe remained argumentative and talkative. Stowe banged repeatedly on the cell door asking the same questions over and over. At the request of BAT staff I placed Stowe back in handcuffs while in the cell to limit her ability to be disruptive in the BAT facility. Upon completion of my paperwork I booked Stowe into the Palm Beach County Jail where I charged her with DUI per FSS 316.193(1) and Resisting Arrest without Violence per FSS 843.02.

My on scene investigation was captured on my issued body worn camera. My dash camera

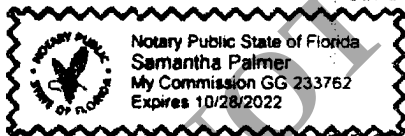
