

PROBABLE CAUSE STATEMENT	<p>On 7/14/2017 a Criminal Mischief was reported to the North Palm Beach Police Department. The victim, Heiley Vivas, reported parking her red Nissan pathfinder bearing Tag # Y44USD ON 7/4/2017 in an assigned guest parking spot at 109 Paradise Harbor Blvd. ON 7/5/2017 Vivas discovered her vehicle to have a large scratch along the passenger side of her vehicle. Officer Lopez had already taken a report of another vehicle also keyed reference case # 17000621 & 17000629. Officer Lopez of the North Palm Beach Police Department was able to retrieve video surveillance which showed. A white male, wearing a hat, parking a white construction type truck in his parking space and walking down towards the victim's vehicle and keying it reference case # 17000621. The male was immediately identified by the board as being a resident at 109 Paradise Harbor Blvd unit 508. Vivas vehicle was not visible in this video surveillance but the scratches on her vehicle were consistent with case # 17000621 & 17000629 damages as well. A photo lineup was conducted with the board from the video surveillance retrieved and Casey Roberts DOB 5/15/1977 was positively ID'd as the suspect in the video surveillance.</p>									
	<p>On 7/25/2017 I was able to meet with Casey at his residence and Casey voluntarily came back with Officer Lopez to the North Palm Beach Police Department to perform and interview. I provided Casey with a bottle of water and read him his Miranda Rights before we began. Casey signed a Miranda card which his warnings were read from and acknowledged understanding and waiving his rights. Casey confessed to keying the victim's vehicle using his house key after showing him still images from the video surveillance. Casey advised he does not know why he did it and he is just "mean". I asked Casey to explain and he asked if he could just pay for the damages to the vehicles. I explained to Casey that 9 cars were identified keyed but only 3 were reported. Casey advised he only thought he keyed 2 vehicles. Casey recalled the incident and advised he was off that day on the 4th of July and believes he was coming back from a store. Casey did say he had been drinking beer that day as well. Casey advised he did</p>


