On Friday, August 4 2017, at approximately 0255 hours, I was dispatched to 502 Rambling Drive Circle, In the village of Wellington, Palm Beach County, Florida 33414 reference a suspicious person.

Upon arrival, I made contact with a white female, later identified as Ms. Cassandra Campbell by her Florida Identification card, at the crossroads of E Rambling Dr. and Rambling Drive Circle. I was advised by dispatch that Ms. Campbell, with another white male, were on the complainant's property when the complainant heard her dogs barking.

Upon speaking with Ms. Campbell, she informed me that she and a white male had driven a friend they met approximately a month and a half ago to his residence on Rambling Drive Circle concerned for his safety -- as he appeared to be drunk. Upon Ms. Campbell placing her purse on the ground, her purse opened up and in plain view, D/S Septien #20750 saw two orange pill bottles with paraphernalia. Upon searching Ms. Campbell's purse the following items were found: 1 Buspirone pill; 1 Alprazolam pill; two orange pill bottles, one with the name Richard Kennedy written on it; one glass pipe; three straws; a small plastic tube; and a small light bulb.

Ms. Campbell, who was read Miranda Rights, admitted to me post Miranda that the pills and paraphernalia were hers. Ms. Campbell further admitted that Richard Kennedy was the white male's aunt's boyfriend. and that both the Buspirone and Alprazolam were not prescribed to her.

Based on my investigation, I find Ms. Campbell in violation of 893.147(1)(A) - possession of paraphernalia, 893.13(6)(A) - possession of a schedule II substance, and 499.03(1) - unlawful possession of prescription drugs.
