

On Sunday 12/17/2017 at approximately 0950 hours, while on patrol at the 4400 block of south Military Trail, unIncorporated Palm Beach County FL, I observed a dark color four door Mercury bearing tag number Y62Ury, not coming to a complete stop at the stop sign located on canal 9th Rd and Military Trail. Prior to the traffic infraction, the driver of the vehicle later identified as Catherine Edelstein was park in the rear of a liquor stop and left the area immediately when she saw my vehicle. Based on this traffic infraction, I got behind the vehicle and I conducted a traffic stop. Upon making contact with her, I advised Catherine the reason for the stop. Catherine stated that she saw my vehicle and apologized for not coming to a completely stopped at the stop sign. While talking to Catherine, I recognized the passenger who she was with as David Birdsong. It should be noted David has a long criminal history for possession of illegal narcotic. At this time David came out of the car and told me that Catherine was on Military trail trying to exchange cigarettes for drugs as she did not have any cash. He also advised she got the drugs from someone that was standing in the back of the liquor store and that was the reason why she speeded away when she saw me. After talking to David, I made contact with Catherine again and I advised her, what I was just informed. From the passenger side in plain view, I could see a white opened grocery bag with several cartons of cigarettes and a small clear plastic baggy with white powder inside. I asked Catherine if the bag was hers and she stated yes. Based on my observations, I read Catherine her constitutional rights from a PBSO Issue card one by one, which she advised she understood. While on Camera and Post Miranda, Catherine advised she had a drug problem and had no idea what she continued doing what she was doing. Catherine also advised she had a drug addiction and she was in desperate need for help. She also advised me she had a daughter that was currently incarcerated and drugs just ran in her family. While I was conducting my investigation, Catherine's husband Larry Edelstein arrived at the scene. Larry told me he knew his wife went out this morning to meet with someone and had a feeling there was something wrong. He advised he was not surprise she was trying to exchange cigarettes for drugs as she did not have any cash on her. The substances was field tested using a # 4 Cobalt Thiocyanate reagent test kit and the substance tested positive for the presence of Cocaine. Base on my finding and the above fact(s) and catherine's full confession, I charged Catherine for violation of F.S.S. 893.13(6)(a), Possession of Cocaine one count. She was placed into handcuffs behind her back, which were checked for proper fit and double-locked. I processed and packaged all seized contraband at the scene and all evidence was placed into the evidence locker at PBSO District 1 second floor. I then transported Catherine to county jail without an incident. This case is cleared by arrest.
