

The following was captured on Jupiter Police BWC.

On 11/24/2019 at approximately 0835hrs I was conducting vehicle traffic enforcement in a fully marked Jupiter Police vehicle in the area of W Indiantown Rd and Center Street, Jupiter, Palm Beach County, Florida. While patrolling the area I observed a white 2 door Pontiac bearing FL Tag 591QAF with two broken tail lights. The vehicle had its break lights illuminated and white light was visible from the rear contrary to Florida State Statutes. Based on the aforementioned traffic violation, I notified NorthCom via my police radio that I would be conducting a traffic stop. As the vehicle turned north onto Thelma Ave I activated my red and blue emergency lights to signal the vehicle to pull over. The vehicle continued into the Jupiter Rehab Facility located at 17781 Thelma Ave, Jupiter, Palm Beach County, Florida. As the vehicle came to a complete stop the female driver immediately exited the vehicle and was told several times to sit back down in the vehicle. The driver stated she worked at Jupiter Rehab and wasn't sure why she was being stopped. I asked the driver for her license and she immediately stated she did not have it. I asked her why and she explained it was suspended. The driver provided a US Passport and identified herself as W/F Catherine N. Finucane (7/28/90).

A records check through F/NCIC and DAVID showed that Finucane had been suspended as of 8/6/2018 and canceled indefinitely on 3/26/2019. Based on this information and the fact that Finucane stated she knew her license was suspended, I developed probable cause to arrest Finucane. Finucane was placed into handcuffs which were double locked and checked for spacing and advised she was under arrest. Finucane was searched by Officer Shaff for any contraband which yielded negative results. Finucane was later transported to the Jupiter Police Department for processing and later transported and turned over to the Palm Beach County Jail without further incident. The vehicle was removed by All Hooked Up Towing.
