On Saturday September 17, 2016 at approximately 2320 hrs., I participated in a prostitution operation on the [REDACTED] unincorporated West Palm Beach due to increased complaints of street level prostitution in the Westgate/Unincorporated West Palm Beach area. Where female deputy sheriffs were posing as prostitutes. The locations were chosen due to recent citizen's complaints and arrests reference prostitution activity.

[REDACTED] was one of the 'decoy deputies' posing as a prostitute in the area of [REDACTED]. [REDACTED] was approached by a white male who was later identified by Florida Drivers License as Cesar Guihurt-Reyes. Guihurt-Reyes was driving a black Ford pickup truck bearing Florida Tag CXQ A81.

Upon contact with [REDACTED] a conversation started, with Guihurt-Reyes asking [REDACTED] "How much for the business?" [REDACTED] asked Guihurt-Reyes if he wanted "suck, fuck, what?" Guihurt-Reyes replied that he wanted to "fuck", which is a common slang/street term for sexual intercourse. [REDACTED] asked Guihurt Reyes \$30.00 and Guihurt-Reyes agreed to that price. [REDACTED] gave the predetermined arrest signal for the arrest team to respond and take Guihurt-Reyes into custody. Once the predetermined signal was given [REDACTED] then responded from a concealed location, and placed Guihurt-Reyes into custody without incident, placing him into flexcuffs checking for tightness and proper fit as per PBSO policy without incident. Guihurt-Reyes was transported to a mobile command post located at Okeechobee Blvd and Military Trail by [REDACTED] for paperwork and processing.

Based on the above facts, I believe probable cause exists to charge Guihurt-Reyes with Offer to Commit Prostitution per F.S.S 796.07 (2)(F). The defendant was later transported to the Palm Beach County jail without incident. This case is cleared by arrest.
