On Tuesday, August 22, 2017, at approximately 1930hrs, I responded to the Bealls, located at 59 N US Highway 1, Jupiter, FL, 33458, in reference to a fraud.							
Upon arrival I made contact with the loss prevention officer, W/M Ben Skyles (10/11/1986) who stated that a white male and white female entered the store, walked to the rear of the store by the shoe isle, placed a pair of Sketchers Men's Shoes into a shopping cart, then procced to the customer services desk. The female then walks out of the store and the male remains at the customer service desk and fraudulently returns the shoes to the store.							
The total value of the shoes is approximately \$80.00 US dollars. The male was given an in store gift card for the full value of the shoes. The male then passes all points of sale and proceeds out the front door of the store with the gift card.							
The entire incident was captured on surveillance video and seen by Ben. The male was detained by police prior to fully exiting the store and was later identified as W/M Chad H Long (03/19/1982) the female was located outside the store in the driver seat of a black Ford F150 truck, FL Tag: HIFR98. The female was detained and identified as W/F Juliette D Shafer (02/02/1965) Ben provided me with a sworn written statement in reference to the incident. I also received a sworn written statement from, B/F Shobhawn Ragoonawan (11/14/1971) who is the cashier that returned the fraudulent item from Chad and gave him a gift car for instore credit.							
I then made contact with MPO.Quinn, who informed me that he had read Juliette her Miranda rights at approximately 1941hrs. I then spoke with Juliette and confirmed that she was read her Miranda rights and understood those rights as they were read to her. Juliette verbally confirmed to me she knew her rights and understood them and did not

Juliette then provided me with a sworn written statement. She freely and voluntarily admitted to me that she took the shoes off the shelf and placed them in the shopping cart and asked her son, Chad H Long, to fraudulently return the shoes for her.

Based on my above investigation, I find probable cause to charge Chad H Long and Juliette Shafer, with Scheme to Defraud per Florida State Statute 817.034(3)(D) 4A3 L7
