This incident was captured on my MVR:

On Tuesday, March 5, 2019 at 0103hrs, I was dispatched to the Marathon gas station located at 5440 W Glades Rd in the City of Boca Raton in reference to a suspicious white male sleeping inside of a red Toyota Corolla (FL Tag KNIE93) parked at Pump #8 for approximately one (1) hour.

Upon my arrival, contact was made with the driver and sole occupant of the above vehicle who was identified as Chad Deckert (12/19/2986). Chad was observed by Officer Torisello (ID #784) in the driver's seat of the vehicle and was not responding to loud knocks at the window. Based on these observations, BRFR responded to check on Chad's condition. Upon their arrival, BRFR found Chad to need no immediate medical treatment and Chad refused to be transported to the hospital. Chad told paramedics on scene that he used heroin intravenously approximately one hour prior.

Based on my observations, Chad was detained pending a drug investigation. I then read Chad his constitutional warnings from a BRPD Miranda card which he stated he understood and wished to speak to me. Chad stated to me post-Miranda that he was in possession of three heroin capsules which were inside of the driver's door panel pocket (immediate reach). Additionally, I observed one syringe in the front passenger seat of the vehicle. Chad stated that he is not prescribed any medication that is administered via syringe and that he uses the syringes for heroin use. Chad also advised that he had a small amount of marijuana inside of a backpack, which was located on the backseat floor board. Inside of the backpack, I located two plastic bags containing suspected marijuana. Additionally, I located an electronic vapor pen containing a brownish liquid. Chad stated the vapor pen contained marijuana. A used syringe was also located in the small pouch of the backpack along with a glass pipe with burnt marijuana residue. A search of Chad's vehicle revealed a total of four used syringes. All narcotics and paraphernalia

The total weight of the marijuana (no packaging) measured 1.3 grams.</p> <p>Based on the above investigation, Chad Deckert was placed under arrest for one (1) count of Possession of Heroin pursuant to F.S.S. 893.13(6)A, one count of Possession of Marijuana under 20 Grams pursuant to F.S.S. 893.13(6)B, one count of Possession of Hash Oil pursuant to F.S.S. 893.13(6)A, and six counts of Possession of Drug Paraphernalia pursuant to F.S.S. 893.147(1)B for the four syringes, electronic vapor device, and glass pipe. Chad was transported to BRPD for processing and later turned over to the Palm Beach County Jail.</p>
