Narrative:

I responded to 954 Brookdale Drive, Boynton Beach, FL 33435 in reference to domestic violence. Upon arrival, I made contact with the complainant, W/M Chad R. Lamar (DOB: L 10/27/1973), who advised he and his girlfriend, W/F Michelle Weintraub (DOB: 11/07/1975), were involved in a physical argument.

Lamar stated he and Weintraub have been involved in a romantic relationship for approximately five years in which they have resided together for the majority of it. Lamar advised he and Weintraub recently decided to end their romantic relationship and remain friends who still reside together in the same home located at 632 North C Street in Lake Worth, Florida. Lamar stated on today's date he and Weintraub decided to take his boat out to which he rents the dock space behind the residence of 954 Brookdale Drive in Boynton Beach. Lamar advised once aboard the boat he and Weintraub began to verbally argue regarding ongoing relationship issues to which Weintraub became enraged and bit him on the middle finger of his left hand. Lamar stated he attempted to defend himself by pushing Weintraub off of him. Lamar stated it was only him and Weintraub on his boat and there were no witnesses to this incident.

Contact was then made with Weintraub who advised Lamar has been physically abusive with her multiple times in the past. Weintraub stated during today's argument that she and Lamar had just parked his boat at his boat dock when they began to argue over ongoing relationship issues. Weintraub advised Lamar then became more upset with her and pushed her in the upper chest causing her to fall back and strike the back portion of her body against the boat. Weintraub stated she also struck the back of her head to which she never lost consciousness. Weintraub advised she then defended herself by pushing Lamar off of her. Weintraub stated there were no witnesses to this incident as it was only her and Lamar on the boat during their physical altercation.

Inspection of Lamar and Weintraub's persons revealed Lamar to be bleeding on his left middle finger and Weintraub to have sustained red marks on the left side of her neck area and the left side of her face. Photographs of the injuries Lamar and Weintraub sustained due to this incident were taken and will be submitted into evidence at BBPD. Lamar and Weintraub refused medical assistance and did not wish to have Fire Rescue respond to the scene.

Due to there being no witnesses to this physical altercation, both Lamar and Weintraub sustaining injuries, and being unable to determine who the primary aggressor was, Lamar and Weintraub were placed under arrest (handcuffs checked for tightness and double locked) for domestic violence pursuant to F.S.S. 784.03.1A1 and transported to the BBPD Booking Facility for processing. Later on, Lamar and Weintraub were transported to the Palm Beach County Jail without incident. There is nothing further to report at this time.


