

<p>On Sunday, February 5, 2017 at 6:27 p.m., I responded to 3109 PGA Blvd (Saks Fifth Avenue) Palm Beach Gardens located in Palm Beach County, FL in reference to a female that had been caught shoplifting. On arrival, I made contact with Diane L. Ambrogio (Asset Protection) with Saks Fifth Avenue in the Loss Prevention Office. In the Loss Prevention Office there was a white female, later identified as Chandra Nicole Moore (DOB: 11/14/1977) from her Florida Driver's License.</p> <p>Ambrogio provided me with a sworn verbal statement recorded on my issued Body Warn Camera (BWC) and advised that she had seen and noticed Moore walking around the store. She noticed Moore from previous times where she had shoplifted from the store. Ambrogio followed Moore throughout the store and saw her first look at two different shaws (scarves). Moore placed the shaws around her neck to wear them and then walked over to the perfume section of the mall. Moore then wrapped two different boxes of perfume within the shaws and place them into her purse. Ambrogio also advised she saw Moore walk to the handbag section of the store, pick up a black in color purse and continued to walk throughout the store. Ambrogio went on to state that an announcement was made over the intercom of the store stating that the mall would be closing at 6:00 p.m. Moore tried to exit the store with the merchandise she had concealed bypassing all the cash register's and not paying for any of the items on her way to exit the store. Ambrogio then approached Moore and asked her to come with her to the Loss Prevention office where she complied and apologized to Ambrogio for trying to steal.</p> <p>I read Moore her Miranda Rights from my issued Palm Beach Gardens Miranda card which she acknowledged and advised she understood. I asked Moore what happened and she stated she grabbed the merchandise from throughout the store with the intent to steal it. Moore advised that she is currently not employed and she steals the merchandise and tries to resale them at Plato's Closet store for cash.</p>

<p>Ambrogio advised Saks Fifth Avenue wished to prosecute. The total amount of the merchandise came out to \$1,826. All the items were recovered and returned. I provided Ambrogio with my business card bearing agency case number and advised her to please call the Police Department when a copy of the surveillance footage would be available to be picked up. Through my investigation, I found probable cause to charge Chandra Nicole Moore with grand theft F.S.S. 812.014(2)(C)(1). Sharika C. Goodwin (DOB: 08/09/1983) a mall Security Officer was able to search and pat down Moore for any weapons on her person since there was not a female officer available. Moore's personal property was turned over to her husband Christopher R. Moore (DOB: 09/17/1984). Moore was placed under arrest and transported to Palm Beach County Jail. My issued BWC was utilized during this call for service.</p>
