

Upon arrival I was informed that Officer Koegel had come into contact with a possibly impaired driver. I was informed the vehicle had crashed into a parked vehicle and then left the scene. Officer Koegel stated he had to brake the window to assist the driver from the vehicle. See Officer Koegel's supplement and supplemental probable cause for this investigation.

I made contact with the defendant, Chantal Obendorf, who was inside the hospital. I read Chantal her Miranda Rights off my Department issued card. She stated she understood and agreed to speak to me. I informed her that Officer Koegel had completed his crash investigation and I was now completing a criminal investigation.

I asked her what she was doing tonight, and she stated she was out drinking. She stated she knew she was drunk. I asked her how intoxicated she was, and she stated a five on a scale of one to ten. She would not tell me how many alcoholic beverages she consumed. While speaking to Chantal I noticed her eyes were bloodshot, watery, and glassy. Her mascara was running down her face as if she had been crying. I noticed her speech was slow, deliberate, and slurred. I smelled the strong odor of alcohol coming from Chantal.

I was unable to perform Standardized Field Sobriety Exercises on Chantal due to her being inside the hospital and did not want to injure her. I did conduct Horizontal Gaze Nystagmus on Chantal. See the DUI Probable Cause for further on this.

Due to not being able to provide a breath sample I requested blood while at the hospital. Chantal refused. I read her implied consent, and she stated she understood.

She stated she would accept the license suspension and would not provide blood. This was taken as a refusal.



Based on the totality of the circumstances I placed Chantal under arrest for DUI. She was later cleared from the hospital. Once cleared from the hospital she was placed under arrest for DUI. I transported her to the Palm Beach Gardens Police Department to complete paperwork. Upon arrival at the Police Department she refused to sign her criminal citation.

I find probable cause to arrest Chantal Oberdorf for violation of F.S.S. 316.193(3)(C)(1) DUI with property damage for hitting one car and causing approximately \$5,000 in property damage. Violation of F.S.S. 316.061(1) leaving the scene of a crash with property damage for leaving the crash scene. Violation of F.S.S. 318.13(3) refusal to sign a criminal citation for not signing the criminal tickets.

Chantal was transported to the Palm Beach County Jail by Officer Coslay.

On the 14 day of October, 2018 at 03:44 (Specifically include facts constituting cause for arrest.)

On Sunday, October 14th, 2018 at approximately 3:44am I was patrolling the San Matera Residential Community (11900 Kew Gardens Ave, Palm Beach Gardens, Florida) in my marked Palm Beach Gardens Police assigned patrol vehicle (#14318). While on patrol I observed a gray 2016 Hyundai Sonata (FL Tag: Y54XDC) parked up on the curb with the engine running. I also observed the vehicle to be partly submerged into a nearby bush.

Upon approach of the vehicle I observed a white female (W/F) in the driver seat, with her seatbelt buckled and the vehicle gear selector in the drive position. The W/F was slouched over the wheel and was not responding to my commands. After further commands I noticed the W/F move her hand but was still slouched over. I verbally commanded the W/F to turn the vehicle off or put the car in park, but the female was not responding to my commands. The W/F reached for the ignition several times and began to move the gear selector.

Just east of the vehicles resting spot I observed a rather large pond. With the W/F appearing to not be responsive to my verbal commands I did not want her to take her foot off the brake pedal and drive forward into the large pond, creating a deadly situation. Based on the exigent circumstances I smashed the passenger side front window of the W/F vehicle, unlocked the door and disabled the vehicle to prevent further issues. I commanded the female to crawl into the backseat to evade the pieces of glass.

The W/F was identified by Florida issued driver's license as Chantel Obendorf (W/F DOB: 03/24/1979). Obendorf had very glassy eyes with a reddish glaze to them, and a strong odor of an unknown alcoholic beverage was emanating from her person. I asked Obendorf if she had taken anything or if she was drinking tonight and she advised, "just drinking." Obendorf also advised, "I am sorry, I am just completely drunk." Obendorf proceeded to advise she was going through a lot of family issues. I had Obendorf step out of the vehicle to bring her over to my patrol vehicle. When Obendorf stepped out of her vehicle

she was stumbling over to my patrol car and I had to escort her over, so she would not fall over. Palm Beach Gardens Fire Rescue arrived on scene (Run# 1810430) and transported to Gardens Medical Center.

After Obendorf was transported to the hospital I located a vehicle (gray Toyota Corolla bearing Florida license plate ABUG81) with heavy front-end damage. The damage to the Corolla was consistent with the damage observed on Obendorf's vehicle, based on paint-scrape transfer from Obendorf's vehicle on the Corolla and broken headlight pieces left at the scene. The location of damage is consistent both vehicles.

I asked Obendorf where she came from and she stated she was at a friend's birthday party at Kirby's in Juno Beach. Obendorf decided to leave to go home. Obendorf stated she could not recall any other details.

This investigation was turned over to Officer Tyler Witt #492 to conduct the DUI investigation.

I smelled the strong odor of alcohol coming from the Defendant. The Defendant was in a hospital bed during my investigation. The Defendant was unable to stand during this time. I noticed her speech was slow and deliberate, and her speech was slurred. She was also very slow when she spoke.
