On 02/11/19, at 0917 hours, the Jupiter Police Department responded to 416 River Edge Road Jupiter, FL 33477 in reference to a residential burglary. Upon arrival Jupiter Police Service Aide Rothgeb made contact with the victim W/M Edward V. Zoder (DOB 10/03/55) and reported the following;

Zoder stated he is the owner of the home and is renting it to W/M Frank Coffaro (DOB 10/31/46). Coffaro notified Zoder of a bicycle that stolen from the garage. Coffaro stated he last saw the bicycle on 02/06/19. Coffaro said he had visitors on 02/09/19. Coffaro said that the garage was open for approximately fifteen minutes on 02/09/19; otherwise, he leaves it closed and locked. Coffaro noticed the bicycle was missing on 02/10/19, at 1830 hours. There was no sign of forced entry. The victim stated the bicycle stolen was a black Schwinn beach cruiser style bike.

On 02/14/19, this case was assigned to me for further investigation. Prior to speaking with the victim a RAPID search was completed for the victim's stolen bicycle. A bicycle similar to the victim's was located at Palm Beach Pawn King. The transaction was completed by W/M Charles A. Aprile (DOB 03/12/83) on 02/10/19. Aprile received \$50.00 for pawning the bicycle. A hold was placed on the bicycle, so the victim could go to the pawnshop and identify his property.

On 02/25/19, I spoke with the victim. The victim stated he went and looked at the bicycle Aprile pawned. The victim confirmed it was his bicycle by the fenders that were painted. The victim told me the original color of the bicycle fenders were chrome; he told me that he painted them black when he bought it. He also said that when he painted the fenders he touched the wet paint, leaving a thumb print on one of the fenders. The victim said the bicycle that Aprile pawned had his thumb print on the painted black fender. The victim recovered his property and paid the \$50.00 the pawnshop gave Aprile.

I attempted to make contact with Aprile through the course of this investigation. I called the phone number listed on the pawn transaction several times and left several voicemails. I went to the address listed on his driver's license. No one was home when I went to the house. I left my business card. On 04/10/19, I received a phone call from Aprile's mother. She stated that Aprile moved out of her house recently and she does not know his current whereabouts. She could not provide a phone for me to contact him.

I obtained video of Aprile completing the pawnshop transaction. A copy of the video was placed into evidence. A comparison was done of the right thumb print on the pawnshop transaction form and Aprile's ten prints I obtained from the Palm Beach County Sheriff's Office. Per Jupiter Police CSI Bryant the prints match, confirming Aprile completed the pawn of the victim's bicycle.

Based on the above stated information I find that there is probable cause to request an arrest warrant for W/M Charles A. Aprile (DOB 03/12/83) for the charges of; Burglary-Dwelling Unoccupied F.S.S. 810.02(3)(B), Theft-Petit F.S.S. 812.014(3)(A), Dealing-In Stolen Property F.S.S. 812.019(1), and False Owner Info Pawned Items Less Than \$300 F.S.S. 539.001(8)(B)&A.



Charles A. Aprile did knowingly enter or remain in a structure which is a dwelling; the property of Edward V. Zoder, with the intent to commit an offense therein, Charles A. Aprile remained in said dwelling surreptitiously, with the intent to commit an offense therein, contrary to Florida Statute 810.02(1) and (3).

Charles A. Aprile did knowingly obtain or use, or endeavor to obtain or use Schwinn bicycle of a value of \$100.00 or more, which was the property of Edward V. Zoder, with the intent to permanently or temporarily deprive Edward V. Zoder of the property or benefit therefrom or to appropriate the property to the use of Charles A. Aprile, contrary to Florida Statute 812.014(1) and (2) (e).

Charles A. Aprile did traffic in, or endeavor to traffic in, Schwinn bicycle, which was property Charles A. Aprile knew or should have known was stolen, contrary to Florida Statute 812.019(1).

Charles A. Aprile did unlawfully and knowingly give false verification of ownership or false or altered identification and did receive money from a second-hand dealer for goods sold or pledged, contrary to Florida Statute 538.04(4) (b).
