On 06/17/16 at approximately 0220 hours I responded to a domestic battery located at 5933 Velvet LN. N in the unincorporated area of Palm Beach County Fl. 33417.

Upon arrival to the scene I met and spoke with the victim a white female later identified by her (FL/DL) as [REDACTED] was very upset and was crying. [REDACTED] was also bleeding from her nose. The blood was coming from her left nostril. I asked [REDACTED] what happened, and she advised her boyfriend (later identified through a familiarization photograph as Charles Gard) and her had been in a altercation. She stated she, and Gard where downtown drinking at a bar when she witnessed Gard talking to a male she recognized as being a local drug dealer. She told Gard he should not be talking to the male, and that she wanted to leave. She advised once she, and Gard returned home they began to get into a verbal argument about her wanting to leave the bar. She stated Gard took her purse, and threw it outside through the front door and told her to leave his house. [REDACTED] stated she picked up her purse and went back inside the residence. She stated she then threw Gard's watch outside to get even with him for throwing her purse outside.

[REDACTED] stated she then went into the bathroom, and Gard followed her inside the bathroom. She advised Gard was very angry with her because she threw his watch outside. [REDACTED] advised Gard grabbed her, and then head butted her in the face. I asked where did Gard grab her, and she stated all over she could not remember because it happened so fast, but she remembers Gard intentionally head butting her in her face causing her to bleed from her nose. She stated after Gard head butted her she grabbed her purse, and left the house on foot. She advised she then called 911. When I met [REDACTED] he was down the street from Gard's residence. I asked [REDACTED] if Gard was still at the residence and she stated she did not know, but she thinks he probably left because he knew she was calling the police. I asked [REDACTED] if there were any witnesses to the incident and she stated no.

Next, I asked [REDACTED] if she was living with Gard and she advised yes for a while now. I asked how long has she and Gard been dating and she advised for approximately six years. I asked her if there has been a history of domestic violence in the past, and she stated yes. She advised Gard had been arrested in the

past for domestic violence against her. She stated she believed there was a no contact order against Gard. I asked PBSO communications if there was a valid no contact order in Palms against Gard and communications advised yes there was. The order of no contact number is 2013CF001784. Later I discovered that the no contact order was invalid and had been closed. Palm Beach County Fire Rescue arrived on scene and treated [REDACTED] injuries. She refused to be transported to the hospital.

Deputy Householder Id 20354 took pictures of [REDACTED] injuries. [REDACTED] was bleeding from her nose and had red marks on her arms and chest area. [REDACTED] also provided a witness statement. Other deputies and myself tried to make contact with Gard at the residence, but there was no answer at the door. Gard was no longer at the residence. I provided [REDACTED] with a copy of the witness statement she provided along with a copy of the victims case information sheet. I also provided [REDACTED] with a copy of the domestic violence right and remedies brochure and provided her with a case number. I also called the domestic violence hot-line, and notified them of the situation. Deputy Householder will be submitting the photographs of [REDACTED] injuries into evidence.

On 6/21/16 I received a email from PBSO communications. The email stated [REDACTED] now has documentation stating she has a broken nose. I called [REDACTED] several times to speak with her about this new information, but she did not answer the calls.

Due to the fact [REDACTED] had visibie physical injuries to her nose, arms and chest probable cause, and know that [REDACTED] stated she has a broken nose probable exists for the arrest of Gard for violating F.S.S. 784.041(1) Felony Battery.
