According to [REDACTED], after searching the apartment for [REDACTED] and having no means of contacting her, he decided to check the pool area and did not locate Nunez. It should be noted that the intercostal is approximately 100 feet east of the pool and there are no fences/ gates, thus [REDACTED] would be able to easily walk into the intercostal if he became lost. [REDACTED] stated that he has never been left home alone at his residence and there is no plan of action set for him if he were to stay at his residence by himself.</p> <p>It should be noted that Livesay is the Property Manager and was able to provide me with a contact number for apartment [REDACTED]. According to Livesay, the apartment was registered to white male, [REDACTED]. [REDACTED] stated that [REDACTED] is [REDACTED]'s boyfriend [REDACTED]. I contacted [REDACTED] via landline ([REDACTED]) and left a voice message requesting him to call me back at 0058 hours. I then spoke to [REDACTED] at 0124 hours, and he stated that he and Nunez were driving back home from a party. I then spoke to Nunez, who stated that she would be home in approximately 20 minutes. Nunez stated that she left [REDACTED] alone in the residence while he was sleeping so that she can "go out."</p> <p>Both Nunez and [REDACTED] arrived home at approximately 0148 hours and they were both separated. I read Nunez her Constitutional Warnings from an agency issued Miranda Card and she stated that she would speak to me and understood her rights. Nunez was crying and stated that she left [REDACTED] alone in the apartment while he was asleep to go to a Halloween party. She stated that she was aware that her decision to leave [REDACTED] alone in the residence without him knowing she was gone was wrong. Nunez could not remember what time she left her residence for the party. It should be noted that I smelled the odor of alcohol emanating from her breath and she was unsteady when she was standing. Nunez stated that she knew it was the first time that she had ever left [REDACTED] alone in the residence. It should also be noted that upon making contact with Nunez, she was wearing a red, thong, leotard and knit black stockings.</p> <p>Officer Gannon spoke to [REDACTED] and he was coherent and stated that he and Nunez went to a Halloween party in Wilton Manors and left their residence at 2300 hours. According to [REDACTED], they left the party after receiving a phone call from BRPD about [REDACTED].</p> <p>Officer Gannon contacted DCF (Department of Children and Families) and spoke to DCF Supervisor Keon Dawkins (DS88094). Dawkins informed Officer Gannon that [REDACTED] was allowed to remain with [REDACTED] until further notice. It should be noted that [REDACTED] was calm, coherent, and not intoxicated. See his supplement for further.</p> <p>Officer Mcquiston completed the Juvenile Referral Form and submitted it into the front desk bin. He also obtained a recorded sworn statement from Castrucci and Livesay.</p>


