Your Affiant was patrolling in the 100 block of Barcelona Dr (La Mancha), in the Village of Royal Palm Beach, Fl 33411. As I approached Bilbao St I noticed a white male wearing a white Polo shirt (3 buttons), tan/yellow camo baggie swim trunks walking along Bilbao St and turning onto Barcelona Dr. The male made eye contact with me and waved. The male walked to a dark colored car which was parked in the drive way of 128 Barcelona Dr, paused in front of the car as he looked at my patrol car to see if I was going to stop. I continued to patrol the neighborhood.

Your Affiant returned to the 100 block of Barcelona Dr. and now saw the same white male walking north bound in the 105 block of Barcelona Dr. The male was in the company of a white female. The couple continued to walk north and finally got into the black car parked at 128 Barcelona Dr. Your Affiant saw the car back out of the drive way and the car sped away on Barcelona Dr in a southerly direction.

Your Affiant followed the dark car which was bearing Florida registration N36-2HX north on Ponce De Leon at an average speed of 35-40 mph. The posted speed limit is 25 mph. The driver of the car made several turns throughout the La Mancha neighborhood and appeared to be lost. Your Affiant initiated a traffic stop at Ponce De Leon and Madrid. The driver of the car was a female and provided me with a Florida drivers license. Your Affiant requested identification from the passenger who was not wearing a seat belt at the time of the stop and the passenger stated he had none. Your Affiant positively identified the white male passenger as the same subject I observed previously at Barcelona Dr and Bilbao St. The white male verbally identified himself to me as Charles Austin Wellington, DOB: 09-01-80, SS # [REDACTED].

Your Affiant checked both subjects in the NCIC and Palm Beach County PALMS system and the driver was located but no record was found for Wellington. Your Affiant asked if Wellington had ever been arrested or showed a local address or any type of identification. Wellington replied he has never had an ID in the state of Florida but had one in Texas. Your Affiant checked Texas and no record was found.

Wellington said the reason he was seen walking around the neighborhood at 3:30 AM is that he was looking for a house to buy. Wellington then said that he was just leaving from a friends house he was visiting but could not provide me with a phone number, address or even physically show your Affiant where this friend lives. Wellington was subsequently released and the driver of the car was issued a warning for
