 On the 5 day of January, 2018 at 22:50 (Specifically include facts constituting cause for arrest.)

On 01/05/2018 at 2250 hours, I responded to 1500 W Glades Road, Boca Raton, FL in reference to a DUI investigation. Upon arrival, I met with Officer Bissoon and he was conducting a crash investigation. Officer Bissoon advised the driver of a 2015 Hyundai Sonata bearing FL Tag #401NQS crashed into a 2009 Cadillac bearing FL Tag #330XGZ. Officer Bissoon advised the driver of the Hyundai had glassy eyes, slurred speech and alcohol emanating from her breath. He also advised she could not find her insurance card. The driver of the Hyundai was identified as W/F Chelsea Ellinger. The driver of the Cadillac, B/F Joann Jackson, advised in a sworn written witness statement that Chelsea was in actual physical control of her vehicle during the crash. Officer Bissoon explained to Chelsea that his accident investigation was complete and I read Chelsea her constitutional rights and she advised she understood. See Officer Bissoon's crash report for further information.

Chelsea told me she has no medical issues and she did not drink any alcohol tonight. It should be noted she later advised she had one glass of wine. I could smell a strong alcoholic beverage smell emanating from her breath and her eyes were glassy/ bloodshot. Chelsea's speech was slurred and her eyes were droopy (ptosis). Lastly, she appeared to be disoriented and lethargic. I asked Chelsea if she would conduct some roadside exercises and she said yes.

First, Chelsea conducted the Horizontal Gaze Nystagmus Exercise. She displayed a lack of smooth pursuit in the right and left eye. She also displayed a distinct nystagmus at maximum deviation and an onset of nystagmus prior to forty five degrees in the right and left eyes. Lastly, Chelsea displayed a lack of convergence in her right eye.

Next, I asked Chelsea to conduct the Walk and Turn exercise and she advised she understood my instructions. Chelsea did not remain in the starting position and she started too soon. Chelsea did not use heel to toe steps and took too many steps on the first nine. Chelsea fell off the line and she took too many steps on the last nine.

Chelsea did not count out loud, she made an improper turn and she used her arms to balance.

Next, I asked Chelsea to conduct the one leg stand exercise and she advised she understood my instructions. Chelsea dropped her foot numerous times, she was swaying and she did not count in the sequence requested.

Lastly, Chelsea conducted the Rhomberg Alphabet and she advised she understood my instructions. Chelsea opened her eyes and had to start over numerous times. Chelsea could not complete the exercise as requested and she was skipping letters in the alphabet.

Based on my training (DRE #028046), experience and the totality of circumstances, Chelsea was placed under arrest for driving under the influence. I transported Chelsea to the Boca Raton Police Department and Officer Rafalko conducted the breath tech operation. Chelsea provided two breath samples of .153 and .134. Lastly, Chelsea was medically cleared at Boca Regional Hospital and transported to the Palm Beach County Jail. Her vehicle was towed to Emerald Towing and the roadside exercises were downloaded into evidence on 01/06/2018. The sworn written witness statement by Joann was placed into evidence on 01/06/2018.

Per Florida State Statute 316.193(3C1), Chelsea did drive or was in actual physical control of a vehicle, while under the influence of alcoholic beverages/ chemical substances and was affected to the extent that her normal faculties were impaired causing property damage/ minor injury.
