




I exited the front lobby in order to walk the parking lot when I observed a white four door Kia bearing Texas registration plates with the rear lights illuminated. As I approached, I could hear the vehicle was running. I waited a few moments to see if the vehicle was going to pull out. I then walked up to the passenger side and observed a female in the front passenger seat holding what appeared to be a US currency bill and she was leaning over the center console. The driver, male later identified as Matthew Howard, was also leaning in toward the center. As soon as I illuminated my flash light, I could see a white powder on the bill in the female's hand, identified by Minnesota DL as Chelsea Swanson. I could also see white powder on a book on the center console. As soon as he saw me, Howard attempted to cover the book with his right arm. The book also had a white powder on it.</p> <p>I introduced myself and told them to keep their hands in front of them and don't move. I requested an additional unit as I suspected, based on my training and experience, the white powder substance based on my training and experience was cocaine. Both Howard and Swanson were cooperative. I asked Howard to hand me the book with the powdery substance. He did.</p> <p>Ofc. Hoewing #163 arrived on scene as back up. Once he got out of his vehicle, I requested his in-car mic and camera be activated as well as for his digital camera.</p>

I had Swanson and Howard exit the vehicle without incident. I did initiate a search of both subjects with negative results for further contraband.

I conducted a search of the vehicle finding several tubes. One tube had more of the white powdery substance whilst the others had rolled marijuana cigarettes; one each in a tube. The tubes matched the same tube the white powder was in. Inside the center console was also a gum container that had another marijuana cigarette.

I tested the white powdery substance utilizing a department issued test and it was positive for the presumptive test for cocaine.

I provided Howard the Miranda Warnings and asked if he understood and would talk to me. Howard said he did and agreed to answer questions. Howard acknowledged the white powder was cocaine and said he was given the drug. I asked what was inside the tubes and he stated it was marijuana. I later weight the tubes and it weighed 7 grams. The label on the packaging indicated it was marijuana with THC dissolate. I asked Howard about the marijuana and he said it wasn't front Florida. I also found a digital scale with marijuana residue on the sides.

In the trunk were two packages of rolling papers and a clear unlabeled tube.

At 0343hrs, I arrested both Howard and Swanson for possession of cocaine. Howard was also charged with possession of marijuana and possession of paraphernalia for use.

I photographed and secured the evidence.

The vehicle is registered to Matthew Howard out of Texas.
