D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Lynch was driving a 2014 Cadillac bearing FL tag 71GID was stopped at the red light at W Indiantown Rd and Alt A1A. Once the light turned green, the vehicle quickly accelerated west on W Indiantown Rd. I paced the vehicle at a consistent 57 MPH in a 45 MPH speed zone. At times, the vehicle traveled faster than 57 MPH, but I was able to get a consistent pace at approximately 1/4 mile of 57 MPH. At one point, the red Cadillac drove in the inside lane and sped up. There was a vehicle driving much slower in front of the Cadillac. The Cadillac got within inches of the rear of the smaller vehicle and jerked the wheel to the right, going into the middle lane. The Cadillac came within inches of striking the vehicle. The Cadillac then changed back to the inside lane, but by using the right turn signal instead of the left turn signal. The vehicle then drifted from the inside to the center lanes.

OBSERVATION OF DRIVER:

Lynch had bloodshot and glassy eyes. Her speech was slightly slurred. She was disoriented and repeated herself several times. She swayed back and forth when standing still. She stumbled while walking and could not walk straight. She had mood swings, from crying to laughing. Lynch had a hard time focusing on directions and instructions.

DRIVER'S STATEMENTS:

Lynch stated she had one glass of wine, then she stated a couple, then she stated two large glasses of wine. She advised she "guzzled" the last glass of wine because she wanted to get home. Lynch said she would probably blow over the limit because the glasses were abnormally large and she drank her last glass quickly. When asked her age, she said "33", but then corrected herself, and said, "43." When I asked where she was driving from, she said her clients home, but then changed it to Duffy's.

ODORS:

Odor of an unknown alcoholic beverage which became stronger as she spoke to me. The odor was still present in the backseat of my patrol vehicle, even after she was removed.

WALK & TURN:

Lynch started the task before being told to do so. She could not maintain the instructed position during the demonstration. She never touched her heel to her toes on any step. She took 11 steps forward and 9 steps back, but then repeated the walk 2 more times. She never counted out loud. She looked straight ahead when walking.

ONE LEG STAND:

Lynch could not maintain the instructed position during the demonstration. Lynch chose her right foot. Her toes were pointed upward. She swayed while performing the task. She did not count out loud. After approximately five seconds she began to move side to side, losing her balance. She used her arms for balance.

FINGER TO NOSE:

She kept her head straight. On the first left, she picked up her right arm, but then put it back down. On the 4th left she picked up her right arm, but then put it back down. On the 3rd right, she touched in between her eye brows.

ROMBERG ALPHABET:

She sang the alphabet. She said, "ABCDEFGHJKLMNOPQRSTUVWXYZ." Then stopped and looked at me.
