 On the **17** day of **February**, **2018** at **21:13** (Specifically include facts constituting cause for arrest.)

On 02-17-2018 at approximately 2039 hours, I responded to 6000 W Glades Rd (Sephoria) in reference to a shoplift. Upon my arrival I met with the manager Diane Ambrogio and the offender Cheryl Frederick.

Ambrogio stated that at approximately 2030 hours, she observed an unknown female, later identified as Frederick, conceal various cosmetic items inside of her handbag. After concealing the items, she observed Frederick pass all points of sale without paying for any of the items. Ambrogio and the staff confronted Frederick where she was escorted to the Loss Prevention office. The total amount of items stolen/recovered was \$727.00. The items stolen/recovered consisted of nine various cosmetic items. Ambrogio provided a witness statement form and a burned copy of the surveillance video of the incident which were submitted into BRPD evidence.

I then met with Frederick who was read her Constitutional Warnings from a pre-printed department issued card. Frederick stated that she was aware of taking the items and that she has been arrested for shoplifting in the past. Based on Ambrogio's statement and Frederick's statement, Frederick was placed under arrest for grand theft under FSS 812.014(2C1). Officer McHugh (ID 653) arrived on scene and conducted a female pat down. Frederick was transported to the Boca Raton booking facility for processing. Frederick was then transported to the Palm Beach County Jail.
