On the **17TH** day of **MARCH** 20**18** at **2221** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On Saturday March 17, 2018 at approximately 2142 hours, I was dispatched to the the Flanigans, located at 2405 10th Ave N within unincorporated Lake Worth, in reference to a disorderly intoxicated female. Prior to my arrival PBSO dispatch received a call from the complaint Doug Hayes, who stated that there was a female at the aforementioned location that was drunk and trying to leave. Hayes advised that the staff were able to retrieve the keys to the subjects vehicle so that she was unable to do so.

Upon my arrival I made contact with Hayes who advised that the female was out by her vehicle and trying to get in it. Further more Hayes advised the female was there earlier in the day drinking. The Female left and came back, Hayes advised that when she came back she seemed out of it and started to demand more drinks. Hayes requested that the female leave and offered to pay for a ride for her, she refused and started to cause a scene in the restaurant. I made contact with the female who was later identified as Christal Leone Holmberg, by way of Florida DL. Holmberg was extremely intoxicated and unable to stand on her own. Holmberg's eyes were blood shot and glossy, and there was an unknown alcoholic beverage emanating from her breath. Hayes was trying to reason with Holmberg and have her leave peacefully in an "uber" or a Cab. She continuously refused and started yelling. A crowd from the business was starting to form and that crowd was starting to record the incident. I requested that Holmberg stop yelling multiple times, she declined and continued to act disorderly. Vehicles that were traveling West bound on 10th Ave N were slowing down to see what the commotion was about.

Based on the above facts, I believe that probable cause exist to charge Christal Leone Holmberg, with Disorderly intoxication contrary to F.S.S. 856.011(1).
