On Saturday, May 26th, 2018, at approximately 1156 hours, I responded to 282 Flamingo Pt. S, Jupiter, Palm Beach County, Florida in reference to a possible violation of a temporary injunction for protection. Upon my arrival, I met with the victim, Anna Davis (W/F 1-23-84) who advised the following during a sworn video taped BWC statement:

Ms. Davis advised her husband, Christian S. Davis (W/M 7-5-84) was served an injunction for protection the other day (5-25-18 see JPDcase#18-002790 reference PBC 15th Judicial Circuit Case No.:50-2018-DR-004966-XXXX-NB) and this morning, she found Mr. Davis had posted on Facebook and tagged her in it. The post is as follows:

"Manipulation and control a hole so deep it burns at the core take everything and lye yourself to sleep. Some people can't be pleased even on your hands and knees. Left for dead without a crum to choke upon the dawn will shine the light and all will be revealed what you barrow and what you steal. I gave it all now left with nothing. Your lies darken my eyes and I see you never loved me. Broken and left for dead dreams of a better place feed to Re hounds of hell. Spend needlessly on what was not needed and drive me to strive for what was promised. A lie so true that it consumed us too. That in the thin line you spread we become nothing other than what is read. My fortune squandered by plundering diamonds that never brought a sparkle to my eyes the lies you tell and all you had me sell led me to nothing now living in this well deep down inside it is dry no more blood to give but I guess this is the life you choose to live. By the power of ten the sin of men will condemn. Is shallow pools circles they will swim"

Ms. Davis then showed me a screen shot of this post on her phone in which at the top, next to the poster's name (Christian Davis), it says he "is with Anna Davis." Being familiar with Facebook, I know this is what posting and tagging someone looks like and the only way to be tagged and mentioned at the top of the post, is by the original poster. Ms. Davis further advised since her husband tagged her in this, all of her

friend's on Facebook can see the post as well as receive notifications about it. According to the time stamp on the post, it appears Mr. Davis posted this at approximately 0200 hours on 5-26-18 and then tagged his wife approximately one hour after that. Ms. Davis advised she had removed herself from the tagged post prior to my arrival.

The following is the narrative of Ofc. Baynum's report (case#18-002790) reference serving the injunction on 5-25-18:

"The following event was caputred on my BWC.

On Friday, 5/25/18 at approximately 2228 hours I arrived at 282 Flamingo Pt S in refernce to serving a no contact order. Upon my arrival, I made contact with Anna Davis (W/F, 1/23/84). Anna advised she just received an order of no contact signed by a judge and it needed to be served to her husband Christian Davis (W/M 7/5/84).

While speaking with Anna, Officers advised they had made contact with Christian at Taco Bell (2048 W Indiantown Rd). I received the order of no contact from Anna and met with Christian and the other Officers at Taco Bell. At 2248 hours, I served Christian with the order of no contact. In the order of no contact it advised Christian had to surrender all firearms and ammunition. Christian was in possession of Sig Sauer 9 mm handgun SN #55B079376. Christian surrendered the handgun with two fully loaded magazines.

I placed the handgun and magazines into the Jupiter Evidence department for safe keeping. I called the Palm Beach County Sherriff's Office Civil Division in reference to Christian being served. I also faxed the form to the Civil Division."

Mrs. Davis then showed me a notarized copy of the injunction in which I noted under Section III. TEMPORARY INJUNCTION AND TERMS/ORDERED and ADJUDGED:

"2. No Contact. Respondant shall have no contact with the Petitioner unless otherwise provided in this section.

a. Unless otherwise provided herein, Respondent shall have no contact with Petitioner. Respondent shall not directly or indirectly contact Petitioner in person, by mail, e-mail, fax, telephone, through another person, or in any other manner."

Mrs. Davis emailed me the two screenshots she had of the Facebook post which were later submitted into evidence. Mrs. Davis also gave me a photo copy of the injunction which is included with the report. I did have Mrs. Davis block her husband from all of her social media accounts, (she advised she only had Facebook) and prior to turning of the GPS tracking on her phone which allowed her to see where her husband was at, noted Mr. Davis appeared to be near the Loxahatchee/West Palm area. I advised Ms. Davis to call the police if her husband tries to contact her again.



<p>At approximately 1548 hours, Mrs. Davis called me and advised she believed her husband was at the McDonald's located at 6760 W. Indiantown Rd. in Jupiter. Ms. Davis stated she could track him on their cell phones using their GPS. Myself and several units responded to the address at which time we came in contact with Mr. Davis who was sitting in his truck in the parking lot. I advised Mr. Davis as to why I was there and that I was aware he tagged his wife in a Facebook post, violating the injunction. I asked Mr. Davis to place his hands behind his back to which he complied. Mr. Davis was placed in handcuffs which were double locked and checked for proper spacing. Mr. Davis requested his wallet, money, and cell phone be locked up inside his vehicle and asked that his mother, Pamela Davis be allowed to pick up the vehicle. I called Ms. Davis (561-371-7162) and she advised she would pick up the truck. I gave the vehicle keys to Ofc. Ferguson who stood by with the vehicle until Pamela Davis arrived.</p> <p>Christian Davis was transported to the Jupiter Police Department and later to the Palm Beach County Sheriff's Office for further processing.</p>
