The following is a brief recounting of events leading to the arrest of Christian Cook on 9/8/2019 for the purposes of booking Cook in to the Palm Beach County Jail. A more complete recounting will follow.

On the above date at approximately 0257 hours I was traveling north on I-95 approaching Donald Ross Road in Palm Beach County, Florida.

I observed a 2013 Ford bearing Alabama license plate 38JG378 traveling north in front of me. The vehicle was swerving visibly within and without its lane. As the vehicle passed the Donald Ross Road overpass and entering the jurisdiction of the Town of Jupiter, it accelerated noticeably. This is a posted 70 mile per hour zone. I visually estimated and radar confirmed a speed of 90 miles per hour. I caught up to the vehicle and initiated a traffic stop. The vehicle stopped on the left hand shoulder. I made contact with the driver, Christian Cook.

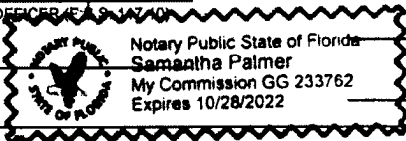
Cook had blood shot glassy eyes and I noticed some issues with his coordination as he retrieved his documents. Cook denied drinking though I could smell the odor of an unknown alcoholic beverage on his breath.

Cook agreed to complete roadsides when asked. I conducted Horizontal Gaze Nystagmus, Walk and Turn, One Leg Stand, Finger to Nose, and Romberg Alphabet. I observed several standardized clues and other cues of impairment. Upon completion, based on the totality of the circumstances, I placed Cook under arrest for DUI. I transported him to the Palm Beach County Breath Alcohol Testing Center and conducted a 20 minute observation period. I requested Cook provide a sample of his breath. After inquiring about Implied Consent and my explaining it to him, Cook agreed to provide a sample of his breath. Cook provided samples of .135 and .132. I then booked Cook into the Palm Beach County Jail where I charged him with DUI per FSS 316.193(1).

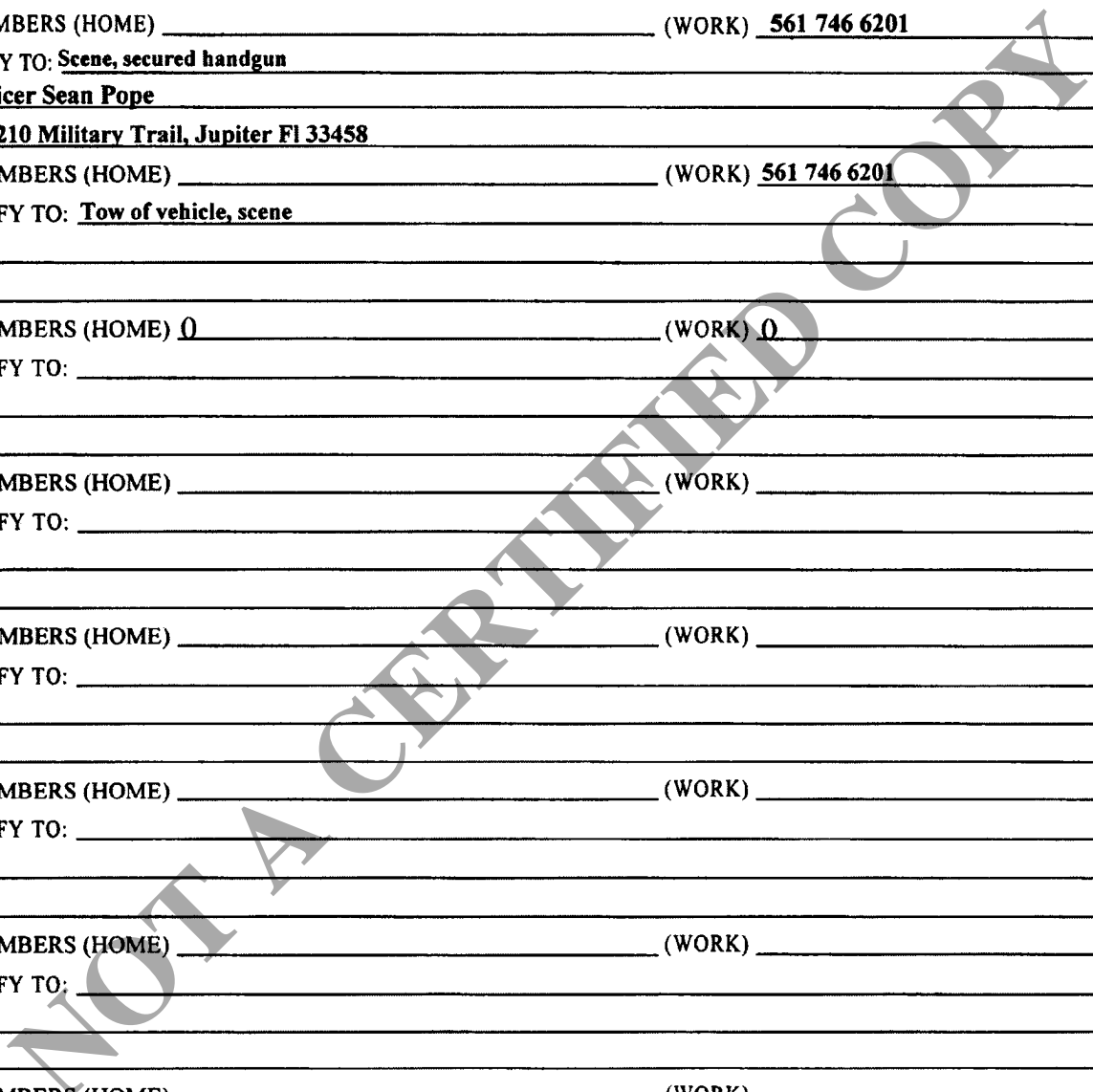
