

Upon arrival in the community, I activated my BWC and was flagged down in front of building number #3.</p> <p>I was approached by the victim COBB, BRUCE who advised he was in a verbal altercation with a male with no shirt on and black shorts. Cobb pointed to the male that was standing near the entrance gate. Ofc Streigold made contact with the male and he was identified as KHAN, CHRISTIANO.</p> <p>Cobb provided a statement which was captured on my BWC, stating he was in the process of parking his truck when Christiano tried to drive his vehicle past him. Christiano was unable to maneuver past Cobb's truck because it was on an angle partially blocking the roadway. Cobb told Christiano that he will be moving but Christiano started yelling vulgar statements at Cobb "Move your fucking car nigger" because Cobb didn't expedite Christiano's request. Christiano then exited his vehicle and approached Cobb still irate and cursing. Christiano proceeded to place one of his hands behind his back (implying he had a weapon) stating "I will cap you". Christiano's motion placed a well-founded fear in Cobb for his immediate safety and feared Christiano had a weapon (firearm) in his possession therefore Cobb grabbed a screwdriver from the passenger seat to protect himself. During Christiano's actions, he yelled for his father KHAN, DAVID who ran down due to his son's screams. Cobb called 911 while David was running to the scene. Once David arrived, Christiano continued to yell even louder at Cobb to move. David was able to separate the two and David walked away towards the entrance gate.</p> <p>A witness MAZZEO, GARY flagged down police and voluntarily provided a statement that was captured on my BWC. Gary stated he was in apartment #315 and heard yelling coming from the roadway. He looked out his west facing apartment and observed Christiano yelling at Cobb. Gary advised he witnessed Christiano place his hand behind his back near his waist</p>

Gary stated he did not see another individuals approach or threaten Cobb but felt that Cobb was in immediate danger.</p> <p>Christiano was placed under arrest with handcuffs behind his back. He was read his Miranda Rights and provided the following statements. He verbally confronted Cobb because he was blocking the roadway stating "It was a fire hazard and he had to move". He continued to yell at Cobb and yell to his father to come downstairs. Cobb then reached for a screwdriver for an unknown reason. He denied ever implying that he had a weapon.</p> <p>Due to the above probable cause exist for the arrest of KHAN, CHRISTIANO for violation of FSS 784.011 ASSAULT - ASSAULT (SIMPLE). Christiano was transported to PBCJ.</p>
