identified as [REDACTED] later identified as Christina Pachay, beating each other as they were walking towards their apartment.

Officer Mquiston, Officer Torsiello, and Officer De Armas arrived on scene as my back-up officers.

Upon arrival, we made contact with [REDACTED] and Pachay in apartment 203. I first spoke to Sorrels about the incident. It should be noted that Sorrels was able to positively identify both [REDACTED] and Pachay as the subjects involved in the incident. Sorrels advised that as he was walking towards the clubhouse, he saw and heard [REDACTED] yelling at someone. He followed the couple and could see Pachay crying from where he was standing. Just as Sorrels was walking away from the incident he could hear the sound of someone getting slapped. As Sorrels went to check on the couple again, he saw Pachay slapping [REDACTED] several times while [REDACTED] had his hands on Pachay's shoulders. It should be noted that Sorrels thought that [REDACTED] had his hands on Pachay so she could prevent further harm to him. As they continued to walk towards their apartment it appeared as if Pachay continued to slap [REDACTED] pushed Pachay away in self defense. Sorrels provided a sworn witness statement which I later submitted into BRPD evidence.


I then spoke to Pachay, who confirmed that she was coming home from a night out with her boyfriend, [REDACTED]. Their Uber dropped them off at the front gate and they began to walk towards their apartment. Pachay advised that she was mad at [REDACTED] for talking to another female; in which they began to argue on the way to the apartment. Pachay admitted that as they were walking she pushed [REDACTED] one time on the shoulder unprovoked. They continued to argue then they went inside the apartment. Pachay advised that [REDACTED] never touched her during the argument. I observed no injuries on Pachay and she never claimed to have any.

I then spoke to [REDACTED] who confirmed the same incident told of me by Pachay. I observed no injuries on [REDACTED] and he never claimed to have any.


Due to Sorrels stating that it appeared as if Pachay instigated the incident, and both Pachay and [REDACTED] stating that Pachay pushed [REDACTED] unprovoked I developed probable cause to arrest Christian Pachay for simple battery (domestic) pursuant F.S.S. 784.03(1). Pachay was transported to BRPD's temporary holding facility for processing and afterwards to the Palm Beach County Jail.
