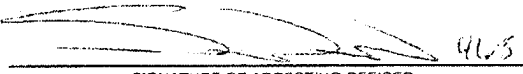
While on the way to the call dispatch advised the female involved in the call left the area in a silver vehicle and the male left the area in a black vehicle (both unknown make and license plates). I arrived in the area and began to lookout for the vehicles involved. I noticed a black four door vehicle driving at a high rate of speed in front of me and passed the location address for the call. I saw a female (possible neighbor) outside of the above-mentioned address and stopped to speak with her and she advised the black car in front of me was involved. I made contact with the vehicle and the driver, Stephen Charnov (10/25/89 W/M), who was shirtless and appeared to be flustered. Charnov stated he was involved in an argument with his girlfriend, Christina Downs (01/26/91 W/F), tonight. Charnov stated she threw keys at him and hit him in the parking lot of the complex then drove away. Charnov stated they have been dating for 3 months are in an intimate relationship. Charnov stated they were drinking at Abbey Road Social Club this evening and got into an argument there. The argument continued back to the house where they remained in the parking lot of the complex. Charnov requested his keys back so he could go inside his house. Downs refused to give the keys back at first then threw the keys at him followed by a strike to the face. Charnov said he doesn't recall what hand or if it was open or closed fist. Charnov sustained a laceration to the right side of his nose indicative of either a key or fingernail scratch.

While speaking with Charnov on scene Downs drove by and Charnov confirmed that was her driving the vehicle. I made contact with Downs who was read her Miranda Warnings from a pre-printed card. Downs advised they were at the Social Club tonight drinking and they were involved in an argument. The argument continued all the way back to the house. She had his house key attached to her key ring and he was wanting it back. She stated when they were in the complex parking lot, he exited the car and continued to ask for the key back. She threw the key in his direction at the ground. She got out of the car and the argument continued. Downs stated she did not throw the key at him or hit him at any point. Downs stated while she was out of the vehicle, she punched her car with a bracelet on a sustained a small red mark because of it. There were no injuries on Downs indicating she was battered by Charnov.

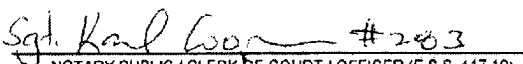
Based on the evidence presented to me and the totality of the circumstances, Christina Downs was placed under arrest for Simple Battery pursuant to F.S.S 784.03(1)(A)(1) with a dating violence indicator. Christina was transported to Palm Beach County Jail without incident.
