On the above date and time, I responded to the above location in reference to a disturbance. The Boynton Beach Dispatch advised via radio that caller saw their neighbors fighting. On my arrival to the area, I met with Ofc. Williams who was with the caller Christina Bermudez, the involved wife Jacquelyn Pett, and the involved husband David Pett. Additionally, there were several other juveniles their parents [REDACTED]. It should be noted that all parties were at the above residence for a birthday party.

I first spoke with Bermudez, who advised that she had got into a heated verbal argument with David. Bermudez stated that they took the argument outside, at which time, David pushed her to the ground. Bermudez reported that David stood over her and began to taught her. Bermudez said that she then ran around the corner and called the Police. Bermudez told me that it was only her and David at the time and that no one struck David. There were no independent witnesses who saw the alleged facts and/or physical markings consistent with her statement (which was photographed & submitted into ADAMS). Bermudez declined medical attention on scene and completed a sworn statement. I then spoke with Jacquelyn.

Jacquelyn stated that she took a shower and went inside the party to observe her husband David yelling "aggressively" at her friend. Jacquelyn advised that David was being verbally abusive for approximately an hour & a half, at which time, David continued to be verbally aggressive. According to Jacquelyn, David started to yell profane comments about family members and Bermudez got offended. Jacquelyn recalls it being at this moment that David & Bermudez started to scream at each other and went outside of the residence. Jacquelyn reported that they came back inside and Bermudez told her that she was pushed down to the ground by David. Jacquelyn stated that David came back into the residence and started to yell "everyone get the fuck out of my house" and she told him to leave. David allegedly refused and Jacquelyn told me that he verbally assaulted her and the family and tried to force his way back inside of the residence. Jacquelyn stated that she pushed David "lightly" and then slapped him in the face after he called her a "cunt & fucking bitch". Jacquelyn said that Bermudez called the Police at this time. Jacquelyn didn't have any markings and photographs were taken & submitted into ADAMS. Additionally, Jacquelyn completed a sworn statement. I then spoke with David.

David advised that there was an argument out on his front porch between Jacquelyn, Bermudez, & friends. David stated that the argument got heated, at which time, he walked outside to see what was going on. David advised that they all began to have a conversation when it became "Bad". David stated that he was "head butted" by Bermudez & he went out in front of the residence. David told me that Bermudez followed him outside of the residence and they continued to argue. According to David, during the argument, Jacquelyn came outside and began to punch him multiple times. David advised that he started to walk away and Jacquelyn continued to punch him in the back of the head. David stated that when she stopped hitting him he turned around and witnessed Bermudez grab one of the juveniles, identified as [REDACTED] and grabbed [REDACTED] by the neck & shoulder and pushed him to the ground. David said that the police were called at this time.

There were several large lumps on the back of his head, which were consistent with him getting punched in the back of the head by Jacquelyn (which was photographed & submitted into ADAMS). It should be noted that several of the juveniles witnessed him being hit. Additionally, David told me that he only recalls being head butted by Bermudez and he didn't see her strike him at any other time during the incident.

I didn't observe any markings to the front of his head consistent with Bermudez head butting him and there were no witnesses for it as well. I then spoke with the other juveniles and their parents [REDACTED]

[REDACTED] both advised that they saw the initial verbal altercation inside the house and they never went outside and/or witnessed any of the physical altercation. I then spoke with [REDACTED], who informed me that he observed a verbal argument between David, Jacquelyn, & Bermudez. [REDACTED] stated that David began to walk outside of the house and David was pushed outside of the residence by Jacquelyn. [REDACTED] told me that Jacquelyn kept pushing David to his car and was being struck by Jacquelyn & Bermudez. [REDACTED] recalls David being slapped & punched in the face multiple times by both females as they kept pushing him to his car. [REDACTED] told me that it was at this time that he told Bermudez to stop provoking David because he was already leaving. [REDACTED] stated that he was grabbed by the neck and shoulder by Bermudez and pushed to the ground and told [REDACTED] "Stay out of this you're not family". [REDACTED] advised that he got back up and told her not to touch him, at which time, he was then pushed again to the ground by Bermudez a second time. [REDACTED] stated that it was at that time that he walked over to the rest of the children. [REDACTED] didn't have any markings consistent with the statement (which were photographed & submitted into ADAMS); however, another juvenile, identified as [REDACTED] witnessed the aforementioned incident. Bermudez & Jacquelyn both told me that [REDACTED] was never pushed to the ground. I then spoke with [REDACTED]

[REDACTED] told me that he witnessed Jacquelyn & Bermudez "pounding" on David, when he saw [REDACTED] try to talk to David. [REDACTED] advised that he saw Bermudez then grab [REDACTED] by the neck and push him to the ground. [REDACTED] told me that he saw [REDACTED] get up again and pushed to the ground a second time by Bermudez. [REDACTED] told me that he never saw David get physical and that no other juveniles were touched. I spoke with the other juveniles, who collectively told me that they saw David get in a verbal argument with Bermudez and Jacquelyn. They all informed me that David walked outside and they witnessed Jacquelyn repeatedly striking David; however, they didn't see Bermudez striking him. Additionally, they also didn't observe [REDACTED] being pushed to the ground.

Due to the aforementioned investigation, I have probable cause to charge Christina Bermudez with Child Abuse W/O great harm per F.S.S. 827.03(1) & Simple Battery per F.S.S. 784.03(1)(A)(1) due to the [REDACTED] & [REDACTED] collaborated statements.
