I was dispatched to 556 SE 28th Avenue in reference to a disturbance involving a W/F later identified as Christina Krupski. Krupski was allegedly intoxicated and breaking things inside the residence. Upon arrival, I made contact with the victim W/M Miodrag Savic who advised that Krupski showed up to his residence extremely intoxicated. I observed several of Savic's items strewn about the house and pieces of glass throughout the garage and kitchen. Savic stated that he met Krupski a few times before because she was looking to rent a room from him from an advertisement he posted on Craigslist. Savic stated that Krupski came to the house and he let her in. He stated that he was having a conversation in the living room and had a drink with her. Krupski asked for more liquor and Savic refused to give her more due to the fact that she was already intoxicated. Savic then stated that Krupski began to hit him in a fit of rage, pushing and punching him with a closed fist. Savic then went outside to get help from his neighbor W/M Ross Pentland.

Upon speaking to Pentland, he advised that Savic approached him outside of the residence stating that a drunk woman was in his house and being violent towards him. He stated that he entered the residence where he observed Krupski standing with a large bottle in her hand yelling and making belligerent statements. Krupski refused to the leave the residence after being asked several times to do so. When Savic attempted to remove the bottle from her hand, she became violent and began to push and punch Savic several times in the head. After doing so, she was then followed Savic and Pentland outside of the residence where she then began to throw several items inside and outside of the residence in the garage, including a few of Savic's glass cups which shattered upon impact (estimated loss from damage to be approximately \$25.00). Pentland then advised that him and Savic left the residence where Krupski was left outside in the front yard. She then passed out in the front yard by Savic's vehicle prior to my arrival.

Upon making contact with Krupski, I observed her passed out on the driveway of Savic's residence. I could smell the strong odor of alcohol emanating from Krupski's breath indicating that she was under the influence of an unknown alcoholic substance. Krupski began to scream and yell in a belligerent manner towards officers. Krupski was then taken into custody by Sgt. Jean and placed into handcuffs (D/L). While placing Krupski in the back of my patrol vehicle (4338), she then became belligerent towards me and began to kick, striking me (in full police uniform equipped with Boynton Beach Police badge and patches) in the pelvic area with her left foot (did not cause any injury). Krupski was then taken into custody and transported to Bethesda Memorial Hospital for medical clearance.



