in the bedroom door (It should be noted that Burns could not state how Schroeder got locked out of the room.) Burns then continues to say that Schroeder hit him several times. While Burns and Schroeder were in an argument Burns was videotaping the incident via phone. The video shows Schroeder intoxicated yelling at Burns. Burns then puts the phone in Schroeder face and she smacks the phone. Burns tells Schroeder not to hit him and Schroeder states I did not hit you. Then in the video it appears she smacks his arm.

I spoke with Schroeder who advised she was sleeping in the bed when Burns came into the room poking her and yelling at her for an unknown reason. Schroeder stated Burns left the room and she quickly stood up and locked the bedroom door to keep from fighting. Schroeder advised she started recording on her phone because Burns continued to yell at her at which point Burns realized that the door was locked and kicked in the bedroom door. Burns then advised they got into a verbal argument and Burns started videotaping. Schroeder stated that Burns then left the room and she did not know where he went. Until Police arrived and she saw him outside with the police. It should be noted that Burns tried several times to find her phone in the bedroom. Both Burns and Schroeder advised the phone was left on the bed. Myself and both parties searched for the phone for upwards of twenty minutes so that Schroeder could show me the video of Burns. However we were met with negative results. Schroeder advised she would leave for the night but was worried Burns had her cell phone and would delete the video.

Schroeder advised she did not wish to leave due to her kids in the house. As we arrived back at the residence Burns had control of Schroeder phone. Schroeder immediately tried to look for the videos and stated they had been deleted.


Burns advised he would leave for the night since the kids were at the residence. However after my departure from the residence Burns arrived home and kicked in the front door.
