On 08/09/19, at 1629hrs, I was dispatched to 825 Center Street #7C (Jupiter Plantation), Jupiter, in reference to a domestic disturbance. While enroute, North Comm advised that they heard crying and screaming in the background of the 911 call stating "get out of my house". They claimed there seemed to be three people involved; two women and one man.

Officer S. Collins and Officer E. Juric arrived on scene a short while before I. By this time, the suspect, Christina Marsh (w/f 03/03/87), had left the residence in a white Chevy Blazer (possibly year 2000). It was learned that the verbal altercation became physical and Christina hit her mother, Dominique Marsh (w/f 03/27/60) and threw a glass Marijuana pipe at her fiancé, Austin Armstrong (w/m 01/17/82). The incident was captured on the Ring surveillance camera that was installed within the residence. I later viewed this while recording it to my body worn camera (BWC).

I obtained two sworn statements via BWC. Both victims were separated prior to the statements being given. Their statements were summarized for this report and are not written verbatim:

First I met with Austin who advised that Christina came into the residence and became verbally aggressive with her mother, Dominique. Dominique was sitting on the stairs when this altercation began and then Christina grabbed Dominique by the arm and hit her multiple times on the left side of her face, shoulder and arm. She apparently was upset because Austin told Christina (via phone) that her mother had left the residence prior to her arrival home. Austin managed to separate them and called the police. When the police were called, Christina fled the scene.

Next I spoke with Dominique who was visibly distraught and crying. She had a laceration/bruise on her left arm that she was caused by Christina. Dominique advised that earlier today, she and her daughter went to have lunch in Alton. They drove together in the same vehicle and later came back to her residence (Jupiter Plantation). Christina appeared sober (Dominique said that Christina has an extreme alcohol and drug addiction and when she drinks she becomes violent). They had lunch with Austin when she started an argument with him outside of Publix. Apparently after that, Dominique went into the liquor store nearby and Dominique subsequently questioned her on it. Dominique drove Christina home and Christina subsequently left with an Uber to an unknown location. Dominique thinks she left to the bar "Hurricanes" in Chasewood plaza. About 25 minutes later, Christina returned in a violent range and began yelling at Austin (the aforementioned) and Dominique. Christina then grabbed Dominique, hit her and threw her to the ground.

In the Ring surveillance video I witnessed the following: Christina was yelling at Austin "you told me she wasn't here!?" "Why would you lie to me!? Is she sucking your dick, is she fucking you!?" Christina then runs to her mother, in a heated demeanor, who was sitting on the stairs. Christina grabbed her mother, by what looks to be the hair and/or arm and hits her multiple times. Christina then throws her mother to the floor. She then continues to yell at Austin "are you fucking my mom, are you?!" and throws what was learned to be a glass pipe to smoke marijuana at him. Christina then left the residence.

It should be noted that recently, yesterday and today, Christina mentioned to Austin and her mother that she wanted to kill herself.

I attempted to email the Ring camera footage to my work email but have yet to receive them. At the time of
