The following incident occurred in the City of Delray Beach, Palm Beach County, Florida.

On 02/07/18 I responded to 40 S Ocean Blvd (Boston's on the Beach) in reference to a petit theft. Upon arrival, I met with the reporting party, Donna Gustin, who stated she was alerted to a white female by a server after two attempts were made to collect a \$105.00 tab. The reporting party stated the white female later identified as Christina Zirpola, ordered and consumed \$105.00 in food and alcohol and then attempted twice to run out without paying. D. Gustin stated the server informed her that C. Zirpola attempted to pay with a gift card (declined) and again with a PNC debit card (declined) at which point he brought the table to D. Gustin's attention. D. Gustin stated C. Zirpola attempted to flee out the rear door of the business and ran to Luna Rosa which is located to the north of the restaurant. D. Gustin stated a valet stopped C. Zirpola at which time she returned to the restaurant.

Based on the above facts, probable cause exists to charge Christina Zirpola with one count petit theft \$100-\$300 in direct violation of Florida State Statute 812.014(2)(E) whereby the defendant entered Boston's on the Beach where she ordered and consumed \$105.00 in food and alcohol with the intent to deprive the victim the full value of the ordered items. The defendant presented a gift card which was declined and presented a PNC debit card which was also declined. The defendant without provocation ran from the restaurant and was escorted back by employees.
