On the 16 day of 2 2018 at 0700 AM PM

On 2-16-18 at 0600 hours a lawful search warrant was executed at 1082 Pinewood lake Court, Greenacres, Florida. DEA SWAT team made entry and secured Harvey Holloway JR, and his girlfriend Christina Zahm. They were both Located on the first floor in the living/TV room. The home was cleared and no other people were located in the home. I then walked up and advised both Harvey and Christina of their Miranda rights. I advised them of the search warrant and we then began the search. The garage was clear except for a speed loader and in the kitchen we found three bent playing cards, a marijuana grow book, CCF and SNAP card for Christina, and a Glock model 27, Serial # VNF529. This was lying open in plain view on the kitchen counter. The gun was loaded and had a magazine in it. In the drawers under the gun I found more ammo a grinder, and some mini bags in a drawer next to the stove. There were also some empty capsule sand a heat sealer and heat sealer bags in the kitchen. In the living/TV room a bag of ammo was fund hidden in a planter. On the coffee table was a bag of marijuana (19g TPW) and some rolling papers and 2 stacks of cash. Christina laid claim to the cash and said she thought it was around 2,000 and may be a little over 2,000. There was also a grinder and a cell phone. The cash was next to the drugs that were packaged in a plastic bag. In her wallet I found a CCF license and a SNAP card for Christina. The second floor was 3 bedrooms. The first room had clothes only. The second room had a few bullets. This room was the bedroom for Christina and Harvey. The third bedroom was a closet. In the closet was a rile box and it contained a FN handgun S# 386194449. This gun was also loaded and had a magazine. There was also a master Piece Arms assault type rifle S3 V9208. There was also 5 boxes of ammo. We also found a makeup bag ad it had 5 stakes of cash in dealer folds. It appeared to be 5,000 but it was not counted on scene. There was also another stack but it was not rubber banded together but it was folded in a dealer fold. Christina later laid claim to the cash and said she thought it was 5,000 in the makeup bag and the extra stack she thought was around a 1,000 but she was not sure of the exact amount. She later claimed she sold a car but she did not know the name of the person she sold it to and did not have a bill of sale for the car. Also in the closet was a bag of marijuana in a black box. It field tested positive as did the first bag and weighed 13g TPW. Also in the closet was a North American Arms revolver S# V29929. This was hidden in a pants pocket of a ladies pair of pants. Christina laid claim to all the guns and says she left the gun on the counter next to Harvey. Harvey admitted he had knowledge of the guns and knows he should not be in a house with firearms as he is a multi-convicted felon. There was ammo also found in the kitchen the second and third bedrooms. The first bedroom was empty. Harvey also admitted post-Miranda that he buys an ounce of cocaine per week for the last year and he sells it in 8-balls and 20-dollar bags. However he would not lay claim to any of the cash found in the house, but Christina also could not account for the sale of the car as to who she sold it to or have a receipt/bill of sale. Harvey has 4 felony convictions in Florida, per his criminal history. The most recent was 2-15-05 for possession cocaine with intent to sell. Harvey and Christina both laid claim to the marijuana in the home. We did find baggies, and capsules used for selling illegal drugs.
