


My body worn camera was used during this incident.</p> <p>I made contact with Christine Figueredo (SU), who was refusing to enter a taxi cab to go home and had the odor of an alcoholic beverage emanating from her breath. Figueredo was resisting Officers lawful commands to sit down and stop causing a scene. Figueredo was yelling at Officers, because she needed access to suite 101 to retrieve her cell phone and purse. In my presence, Figueredo was talking to Ofc Basinger 428, when he turned around to walk away from her. Figueredo balled both of her fists and attempted to approach Ofc Basinger from the rear. At this time, I escorted Figueredo to a bench and told her to remain seated. Figueredo then attempted to get up and engage Officers again. At this time, Ofc Koegel 456 and I placed Figueredo in handcuffs. While placing Figueredo in handcuffs, she braced, tensed and attempted to pull away from me, while Officers were instructing her to stop. It should be noted, all Officers involved were in standard patrol uniform with badge and patches clearly visible. All Officers also identified themselves as members of Palm Beach Gardens Police Department.</p> <p>Given Figueredo's physical condition and unknown level of intoxication, she was transported by this Officer, Ofc Basinger and Ofc Ray 415 to JFK Emergency Room in Palm Beach Gardens, located at 4797 PGA Blvd for further processing.</p> <p>Upon entry to the Waiting Room, Figueredo was told to sit in a chair. While assisting her in taking a seat, Figueredo did intentionally kick this Officer in the groin, on the right side. Figueredo was then placed into a room for examination. While being assisted onto the bed, Figueredo then intentionally kicked Ofc Ray in the right side of his chest.</p>


