Driving Pattern

Actual physical control (physical evidence putting the driver behind the wheel)

I responded to the area of S. Australian Ave. and Belvedere Rd. in reference to a motorist passed out behind the wheel. Upon arrival I observed a black Chevrolet Sonic in the outside northbound lane just South of the intersection. As I placed my vehicle in front of the Chevrolet I observed the driver in the driver seat with her head tilted down. I observed a black Ford Expedition stopped behind the Chevrolet with its four way flashers on. I made contact with Clint Griffin who was in the Ford. He identified himself as the person who called the police. He stated he noticed the vehicle was not moving and he got out of the vehicle and approached the Chevrolet. Griffin stated he observed the driver sitting in the driver seat with her head tilted down. Griffin stated he yelled out to her and she did not respond which is why he called the police. I walked back to the Chevrolet and observed the vehicle gear in drive and the drivers foot on the brake. WPBFR arrived and Ofc. Sadlon was able to gain access to the vehicle through the driver door. I watched Ofc. Sadlon place the vehicle in park and remove the keys. Ofc. Sadlon and the medics woke up the driver. The driver who was the sole occupant of the vehicle was identified as Christine Rubino by FL DL.

Observation of Driver

Upon making contact with the driver she had her head tilted down and appeared to be sleeping. Once access was gained into the vehicle and the door was opened I could smell the strong distinct odor of an unknown alcoholic beverage emitting from the interior of the vehicle. The driver immediately became agitated and upset. The drivers speech was very slurred and her answers to questions were not conducive to the question that was asked. Once the drivers sunglasses were removed I could see her eyes were bloodshot and glassy and very slow to react. Once the driver stepped out of the vehicle she almost fell. The driver had difficulty maintaining balance while standing. While speaking to the driver the odor of the unknown alcoholic beverage became stronger off of her breath.

Drivers Statements:

After waking up the driver stated she did not know what was going on. The driver stated she was tired and fell asleep. The driver stated she was not in the roadway. While speaking with the medics the driver stated she did not have anything to drink. The drivers answers to their questions were "no". The driver told the medics she did not have any medical issues, was not diabetic, and was completely healthy. Once the medics stated they could not treat her any further I advised the driver I was conducting a DUI investigation. The driver told me I was not and began to stumble away. Ofc. Sadlon and myself grasped the drivers arms to keep her from stumbling into traffic. I again attempted to tell the driver I was conducting a DUI investigation and she stated I was not and she did nothing wrong. The driver attempted to walk away again at which time I placed her into handcuffs for the safety of the driver, the officers, and medics on scene. The driver was advised she was under arrest for driving under the influence. The driver stated no I am not.
