Pollow opened the door and explained that he was a victim of dating battery last night in Boca Raton Florida (17-154220). Pollow explained that Niman was arrested for the incident, and was transported to Palm Beach County Jail. Pollow stated that Niman was in court this morning, and a protection order issued, so no contact could be made by Niman toward Pollow.

The copy of the no contact order was located. On 11/21/17 a Circuit County Court Judge (name not legible) signed and signed a no contact order in which Niman understood and signed. The order clearly indicated that Niman should have no contact at all with Pollow.

Niman stated that she knew she signed the order, but came to retrieve her cell phone. It should be noted that in the order, it indicates that Niman should have contacted the local law enforcement before arriving at the residence to retrieve her phone. According to Pollow, Niman came to the residence uninvited. The order also explains that Niman should not have any third party candidate contact Pollow. According to both parties, Niman used her mother to contact Pollow several times throughout the day.

Search incident to arrest, three green pills were located inside of the black purse which was around Niman. The green pills had the a large M on the front followed by a (C 14) on the back. Upon further investigation using Drugs.Com the pills were identified as Clonazepam. Clonazepam is listed as a schedule 4 controlled substance. Niman did not have any documentation proving that the pills were prescribed to her.

Based on the following Niman was arrested for a violation of protection against domestic violence according to F.S.S. 741.31(4A), and possession of a controlled substance without a prescription according to F.S.S. 893.13(6)(A).
