## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Two PGA National Security Officers, Charles Creger and Scott Freeman provided sworn-oral statements that the driver, later identified via South Carolina Driver's License as Christopher Allen Gwaltney was driving a white Mazda truck bearing South Carolina Tag 3710KH.

## OBSERVATION OF DRIVER:

While speaking with Gwaltney from the hood of the vehicle, I could smell the odors of an unknown alcoholic beverage emitting from his breath as he spoke. I observed Gwaltney's to be wearing a blue polo shirt, khaki shorts, and flip-flops. Gwaltney's speech was slurred, mused-mouth and he provided inconsistent answers and repeated his answers. Gwaltney was unsteady on his feet and walked with a sway. Gwaltney leaned on his Mazda truck multiple times to maintain his balance.

## DRIVER'S STATEMENTS:

Gwaltney initially stated he did not drink alcohol, then immediately corrected his statement stating he drank much earlier in the day. After arrest, Gwaltney stated he was not driving, then at the BAT stated I can't prove he was driving that I should have arrested him for "Drunk in Public" as that would stick.

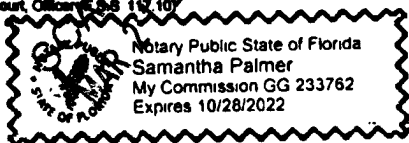

Gwaltney complained that he broke his right toe and would find this task difficult. I questioned why he didn't state this earlier and he didn't have an articulable explanation. I attempted to explain and demonstrate the instructions to Gwaltney, but due to his impairment, he was unable to maintain balance. As I began to give him instructions, he complained that his toe was hurting, and he could not perform the task but without being asked, he started the task prior to receiving instructions on how to perform the task and prior the command to start. I called Gwaltney to come back to the starting position and he continued to complain about his toe and how he could not perform the task. Gwaltney struggled to maintain his balance and blame it on his toe. Gwaltney even poked his toe, however, did not complain when he pressed his finger into his toe. Gwaltney began to argue with officers at the scene and refused to perform the task.

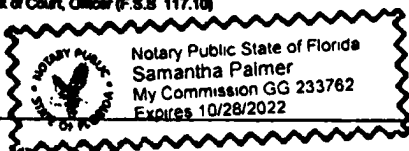

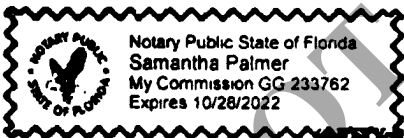
