On 5/15/18 around 1250 hours, I was on patrol in my PBSO issued marked patrol vehicle (asset #75089) when I observed the below series of events which was captured by my in car video and audio recording and will be uploaded to the PBSO web server as evidence:

I observed a Black Lexus RX300 bearing Florida tag 125NKW commit a right of way violation approaching and entering the intersection of Lake Worth Road and Lake Osborne Drive. I could further see the front seat passenger was not wearing a seatbelt. The vehicle traveled westbound on Lake Worth Road at which point I activated my overhead red and blue emergency lights and initiated a traffic stop in the 2500 block of Lake Worth Road. I approached the vehicle on the passenger side, and could see the vehicle was occupied by the driver (later identified via his Florida Driver's license as Christopher Dearth) and front seat passenger (later identified via his Florida Identification Card as Michael King). When King rolled down the window, I could immediately smell the odor I recognized from my training and experience to be marijuana emanating from inside of the vehicle. I called for backup to respond, and once backup units arrived on scene, I went to the driver's side of the vehicle and ordered Dearth out of the vehicle. Dearth refused to get out of the vehicle and started to film our encounter from his cellphone while ignoring my repeated and lawful orders for him to step out of the vehicle. I explained to Dearth that I had probable cause to search him and the vehicle pursuant to the smell of marijuana coming from inside, and I further added that I was going to pepper spray him if he did not step out of the vehicle, at which point he finally complied. I placed Dearth in handcuffs that were checked for proper fit and double locked. In his left front pants pocket, I located a black cannister containing 2.5 pills I recognized from my training and experience to be Oxycodone 30mg. Further search of the vehicle revealed 4 grams of marijuana contained within various unlabeled cannisters scattered about the interior of the vehicle, and a glass pipe containing burnt marijuana residue. Search and interview of the passenger King, revealed no contraband and no knowledge of drugs within the vehicle. King stated none of the drugs in the vehicle belonged to him, and further admitted Dearth's vehicle smelled like marijuana.

I later field tested the marijuana located inside of the vehicle with a duquenois reagent field test kit and it tested positive for THC. I went back to my patrol car and read Dearth miranda warnings from a PBSO issued miranda card. Post miranda, Dearth admitted _____ and admitted _____ Dearth stated _____ and admitted _____



