<p><b>On June 14, 2017 at approximately 2245 hours, I responded to 4739 Orleans Ct, Apt D, in unincorporated West Palm Beach, located in Palm Beach County in reference to domestic disturbance complaint.</b></p> <p><b>Upon arrival I met and spoke with the complainant Joel McDonald who stated that she and her ex-boyfriend Christopher Irizarry got into a verbal argument. Joel stated that she had gone to the above address to pick up Christopher's sister identified verbally as Kristelle Irizarry. Joel stated that Christopher approached her and started yelling at her, calling her names and started pushing her while she was in the living room area of the apartment. Joel stated that Kristelle came into the living and noticed that Christopher was getting aggressive with her so Kristelle told him to stop. Joel stated that he did not stop. Joel stated that Christopher immediately grabbed Kristelle by around her neck. Joel stated that she started hitting Christopher in an attempt to get him off of Kristelle.</b></p> <p><b>I then met with Kristelle who advised that she went home to get dressed. Kristelle stated that Christopher, Joel and Tina Savarese started arguing in the living room. Kristelle stated that she told Christopher to stop arguing with Joel and to leave her alone. Kristelle said she then went into the bathroom to do her makeup and heard fighting. Kristelle stated that she left the bathroom and went into the living room and saw Christopher trying to put his hands on Joel. Kristelle then said that Joel and Tina went into her bedroom to calm down. Kristelle stated that she went to Christopher to try and calm him down but he started calling her names and grabbed her by the neck. Kristelle stated that Joel came out of the bedroom right afterwards and started fighting Christopher. Kristelle said after the fight, she and Joel went back into the bedroom. Kristelle stated that Joel smashed his phone to the ground. Kristelle said Christopher then tried to get into the bedroom and was banging on the door. Kristelle said she then called the Police which arrived shortly after.</b></p> <p><b>Based on the above information, there is probable cause for the arrest of Christopher Irizarry for Simple Battery Domestic Violence and Simple Battery Dating Violence as Joel is his girlfriend of 8 months with whom he has maintained an intimate dating relationship with up until approximately 1 month ago, furthermore there is probable cause for Christopher Irizarry for simple battery Domestic violence related as he did in fact touch or strike the person of Kristelle Irizarry who is his sister.</b></p>
