

On the 2 day of July, 2018 at 23:17 (Specifically include facts constituting cause for arrest.)

On Monday, July 02, 2018 at approximately 2234 hours I arrived at 2224 Palm Beach Lakes Blvd in reference to an intoxicated male. Upon arrival I made contact with Twin Peaks Bartender Jordyn Paryz (W/F DOB:10/30/1992) on the back patio who advised the white male later identified as Christopher Palmer (W/M DOB:04/06/1974) was extremely intoxicated causing a disturbance. The restaurants patrons and staff had to stop what they were doing because of the scene Palmer was making inside. Paryz advised Palmer was in the white car behind the restaurant .Paryz did advise she took Palmers keys. I proceeded through the patio to the rear of the building towards a white Lexus CT200 bearing Florida tag (Z56-GUI). As I approached the vehicle Palmer exited the vehicle driver side door and exited towards the rear of the vehicle. It should be noted that Palmer could barely stand and was stumbling into his vehicle and the vehicle parked to the north of the Lexus.

I advised Palmer to lean against his vehicle because he was extremely intoxicated and he could not stand up. Palmer refused to lean the car and continued to approach me. As I directed Palmer to lean against his car several more times because he was intoxicated he continued to ask "for what." Palmer then advised if we were there for him to call his wife. Officer McBride was able to get ahold of Palmers wife via Palmers cell phone. Palmer continued to approach Officer McBride several times and was requested to not approach him like that. As Officer McBride made distance so he could talk to Palmers wife on the phone Palmer directed his attention to me.

Palmer then approached me with his hands clinched on his waist and shoulders directly squared towards me. I advised Palmer "You do not want to walk up on me like that." and put my right hand directly in front of me to create distance between me and Palmer. Palmer replied with "really, really dude." And continued to approach me. I pushed Palmer away a second time and advised him he approached me again he would be placed on the ground. Palmers hands came off of his waist and approached me a third time. In fear

that Palmer was going to strike me with his fist I closed the gap towards Palmer grabbing him behind the the top of the shoulders and performed a hip toss over my right hip.

Once Palmer was on the ground he continued to attempt to stand up and pull away. Palmer refused several times with officer's commands to place his and behind his back and stop resisting. Palmer eventually loosens his arms and we were able to place handcuffs on Palmer.

At this time I have probable cause to arrest Palmer per F.S.S 843.02 RESIST/OBSTRUCT OFFICER W/O VIOLENCE, F.S.S 856.011 DISORDERLY INTOXICATION, F.S.S 784.07 ASSAULT - LAW ENFORCEMENT OFFICER
