On 08/05/17 at approximately 0607 hours I responded to the area of 4865 OKEECHOBEE BLVD, which is located in unincorporated WPB, in ref to a man down call/disturbance. While en-route PBSO communications advised me that an unidentified anonymous complainant called 911 and reported a W/F and W/M were in a disturbance. PBSO also received a call from W/F Brittany E. Stage, who reported that her boyfriend, W/M Christopher L. Bradley, was intoxicated and unresponsive. Brittany requested EMS, which was en-route.

Upon my arrival I noticed Christopher was lying on his back on the side of the roadway, which is a private business entrance located just north of Okeechobee Blvd. Brittany, who was also highly intoxicated, was screaming and acting belligerent. Both Christopher and Brittany were in a location where they could be struck by a passing vehicle as they were not completely off the roadway.

As I approached Christopher on foot I noticed he was breathing, but not responsive and unconscious. Palm Beach County Fire Rescue was en-route ref run number 17-08489. I attempted a sternal rub to Christopher's upper chest area in order to wake him up in an attempt to evaluate him and gather additional information for the rescue. After Christopher regained consciousness he started acting belligerent by yelling and cursing at me. PBCR station #28 was on scene at this point and various fire fighters were walking up to my location.

Myself and B/S Blakney I.D. 8235 attempted to hold Christopher down by his arms so EMS could evaluate him. Myself and B/S Blakney were dressed in our issued PBSO class B uniform. Christopher then used his left leg to kick me in the left side on my stomach and hip area. Christopher was then placed in handcuffs which were double locked.

While walking Christopher to the rear of my marked patrol car Christopher stated "when I get out I'm going to find you." I perceived this statement to be a direct threat on my life and now have a well founded fear that Christopher will attempt to locate me and harm/kill me at a later date. Christopher's verbal threat was captured on my in-car camera footage and was also witnessed by B/S Blakney.

Based on Christopher's behavior he and what I observed probable cause exist to to arrest Christopher for battery on a LEO, disorderly intoxication and corruption by threat against public servant. Christopher was later transported to the PBC jail for booking and processing. I also collected a sworn written statement from PBCPR L.T. B. Dillmer, who witnessed Christopher kick me. This case is cleared by arrest.
