Upon my arrival, I made contact with hotel employees who directed me to a White Male, later identified as Christopher Lytal (W/M 01/11/1973), who had been yelling, falling over, and refused to leave the premises.</p> <p>Upon making contact with Lytal, I observed that he could not support himself, had slurred speech and sunken eyes. These facts led me to believe Lytal was severely intoxicated. While talking to him and trying to resolve his issue of finding a way home, he repeatedly cursed loudly and insulted the officers on scene, which drew numerous citizens to come look to see what was happening. Lytal repeatedly attempted to stand up after being given a lawful order to remain seated. Lytal attempted to hit my hand away multiple times while I was insuring that he remained seated. While speaking with Lytal, he then swatted at my hand, at which time he was placed under arrest for Disorderly Intoxication.</p> <p>Lytal is being charged with Disorderly Intoxication in pursuant to FSS 856.011 due to the fact that Lytal appears intoxicated, disturbed the employees of the hotel, was cursing loudly drawing the attention of citizens, and for attempting to hit my hand while communicating with him.</p> <p>Lytal was transported to the Palm Beach County Jail and transferred to the care of the Palm Beach County Sheriff's Office.</p>
