On the 29 day of July, 2018 at 13:52 (Specifically include facts constituting cause for arrest.)

On Sunday, July 29th, 2018, at approximately 1151 hours, I was patrolling the 3700 block of Broadway, in a marked police vehicle and in full police uniform, when I observed several subjects surrounding a black pick-up truck. The truck was stationary at 3700 Broadway (McDonald's) while its front bumper partially blocking southbound traffic on Broadway.

Upon sight of my police vehicle, the concerned citizen began frantically flagging me down while pointing toward the pick-up truck. Upon exiting my police vehicle, I observed a black 1998 Chevy Cheyenne 1500, bearing Florida tag Z83DFG stopped at the entrance of 3700 Broadway (McDonald's). The rear bumper of the truck was in the parking lot of the aforementioned business while its front bumper was partially obstructing the southbound traffic on Broadway.

Upon approaching the vehicle, I observed the sole occupant, later identified through his Florida driver's license as Christopher S. Malone (d.o.b 05/06/1971) sitting in the front driver seat. The front driver side door had fresh scrapes and damages and the driver's side window was shattered. The vehicle appeared to have recently collided with an unknown object. Malone's head was tilting backward with both of his eyes closed. The vehicle's shifting gear was on drive while Malone's left foot was resting on the clutch and its right foot was on the brake pedal. The vehicle's engine was on. I reached inside the vehicle and I turned off the engine and activated the emergency brake.

At that point, I requested medical assistance while I attempted to wake up Malone. After several failed attempts, I informed Riviera Beach Communication Operators to inform Riviera Beach Fire Rescue (RBFR) of the subject's condition. Malone was in and out of consciousness. Malone was having a difficult time staying awake. RBFR responded on scene shortly and began providing medical assistance to Malone.

While Malone was being treated by RBFR, I made contact with several witnesses, including Angela Tyson-Meadows (d.o.b 05/27/1960) who advised that Malone was traveling southbound on Broadway when he abruptly swerved and crashed onto a "One Way" sign that was located on the median in the 3700 block of Broadway. The witness further stated that Malone then pulled into the parking lot of McDonald's, made a U-Turn and proceeded back toward Broadway. As Malone approached the intersection, they noticed that the vehicle stopped. The witnesses further advised when they noticed that the vehicle was not moving, they approached it and noticed that Malone was "passed out". It should be noted that with the exception of Tyson-Meadows the other witnesses did not wish to be identified in this report.

After Malone was treated by the RBFR, I made contact with him. Upon making contact with him, he appeared to be disoriented and confused. Malone did not know where he was or his father's information. Malone had to be assisted to get out of his vehicle and onto the RBFR stretcher. Malone was then transported to St. Mary's Hospital for further treatment.

While at the hospital, Malone spontaneously uttered to the nurse, in the presence of Ofc. B. Ivory ID# 5851 that "I'm using 5mg of Percocet". I made contact with Malone again and I informed him of his Miranda rights. Malone acknowledged that he understood. I then read to Malone the Implied Consent, requesting for a blood sample. Malone advised that he "wanted a lawyer". Due to the fact that Malone had requested a lawyer, all questioning ceased.

Based on the above information, Christopher S. Malone was transported to the Palm Beach County Jail and charged with one count of Refusal to Submit to a blood/Alcohol/Urine test per FSS316.193(9).
