The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 28 day of June 2018 at 19:15 (Specifically include facts constituting cause for arrest.)

The following incident occurred in the City of Delray Beach, Palm Beach County FL. I responded to 25 NE 2nd Ave "Blings And Things" in reference to a delayed violation of a restraining order. Upon arrival I met with the victim, Mary Brinkman, who stated that she has a restraining order against her exboyfriend, Christopher Pisciotta. Brinkman claims he has violated the order by contacting her numerous time since he has been served. On this date Brinkman stated she was at work and answered the work phone without checking the caller ID assuming it was a customer. To Brinkman's surprise it was Pisciotta on the other end. Brinkman immediately questioned why he was calling and asked him to leave her alone but according to Brinkman, Pisciotta was persistent on keeping her on the phone to talk about their relationship. According to Brinkman the exchange only lasted 30 seconds before she hung up the phone. Only a few minutes later Pisciotta called her again. Once again he called from his cell phone which came up on the business's caller ID, however this time Brinkman noticed it was coming from Pisciotta's cell phone and did not answer the phone. In addition to this Brinkman showed me several text messages from Pisciotta's phone number on the three consecutive days (June 26th, 27th and 28th) after he was served with the injunction on 6/25/18. All or the messages were related to their break up. A photo was taken of the caller ID and of the text messages via my BWC. A computer check showed that Pisciotta was served by the Palm Beach County Sheriffs Office (DS. Lentini #7321) on 6/25/2018 at 1015 hours. The court order does in fact show Brinkman as the "Protected Person" (OCA/DR18-5877SB). I then went to DBPD to call Pisciotta from a taped line to get his side of the story. I called the phone number that I obtained from the businesses caller ID (941-685-9198). A male answered the phone and confirmed that I was talking to Christopher Pisciotta. Pisciotta admitted to calling Brinkman at the business. When I asked him why he called he told me he just wanted to see if Brinkman still loved him. As a result of the above circumstances it appears PROBABLE CAUSE exists to charge the defendant Christopher Pisciotta under F.S.S 784.047 VIOLATION OF INJUNCTION AGAINST REPEATED VIOLENCE.
