Potter wrote the driver's license number, contact number, and address on the contract which Hawkins signed. On 09/21/16, Hawkins extended the rental for the equipment until 10/18/16 and used the same MasterCard for \$669.13. On 10/18/16, Hawkins did not return the trailer and hitch. They attempted to contact Hawkins several times by telephone (561-235-9401) but got no answer. Manager Salerno attempted to make contact with Hawkins at the address listed on the contract (American Home Services - 9848 Grand Verde Way, suite #1107, Boca Raton) but the suite was vacant. A demand letter was mailed to Hawkins by certified mail informing him of the accumulated charges of \$11,798.30 as of 11/14/16. On 12/09/16, the trailer was located by FHP in the area of Gateway Blvd and I-95. A representative from Sunbelt responded and took possession of the trailer. The trailer was loaded with debris and was damaged (broken jockey leg, rear doors, and a bend fender). The hitch was not recovered. Hawkins's total bill from 10/18/16 to 11/14/16 is \$12,454.29 with the following detail:</p> <p>"      4 weeks rental - \$847          "      Unrecovered hitch - \$50.99          "      Trailer value - \$10,951.30          "      Dump removal - \$105          "      Estimated repair of damage to trailer - \$500</p> <p>Lanese wanted to pursue criminal charges against Hawkins and a copy of the taped statement was placed into evidence.</p> <p>On 12/22/16, I spoke to Hawkins on the telephone and he agreed to meet with me.</p> <p>On 12/27/16, Lanese advised that the demand letter sent via certified mail to Hawkins's place of business was returned. A copy of the return receipt was placed into evidence.</p> <p>On 12/27/16, I attempted to make contact with Hawkins via telephone but got no answer. I drove to 9848 Grande Verde Way, unit #1107, in Boca Raton to make contact with Hawkins but the office space was vacant.</p> <p>Based upon the above investigation, there is probable cause to believe that W/M Christopher Hawkins DOB 01/18/85 violated Florida State Statute 812.155(3) for leasing equipment (trailer and hitch) from Sunbelt Rentals, failing to return the equipment, and failing to pay the overdue bill. Manager Salerno attempted to make contact with Hawkins at the address listed on the contract (American Home Services - 9848 Grand Verde Way, suite #1107, Boca Raton) but the suite was vacant. A demand letter was mailed to Hawkins by certified mail informing him of the accumulated charges of \$11,798.30 as of 11/14/16. On 12/09/16, the trailer was located by FHP in the area of Gateway Blvd and I-95. A representative from Sunbelt responded and took possession of the trailer. The trailer was loaded with debris and was damaged (broken jockey leg, rear doors, and a bend fender). The hitch was not recovered. Hawkins's total bill from 10/18/16 to 11/14/16 is \$12,454.29 with the following detail:

- " 4 weeks rental - \$847
- " Unrecovered hitch - \$50.99
- " Trailer value - \$10,951.30
- " Dump removal - \$105
- " Estimated repair of damage to trailer - \$500

Lanese wanted to pursue criminal charges against Hawkins and a copy of the taped statement was placed into evidence.

On 12/22/16, I spoke to Hawkins on the telephone and he agreed to meet with me.

On 12/27/16, Lanese advised that the demand letter sent via certified mail to Hawkins's place of business was returned. A copy of the return receipt was placed into evidence.

On 12/27/16, I attempted to make contact with Hawkins via telephone but got no answer. I drove to 9848 Grande Verde Way, unit #1107, in Boca Raton to make contact with Hawkins but the office space was vacant.

Based upon the above investigation, there is probable cause to believe that W/M Christopher Hawkins DOB 01/18/85 violated Florida State Statute 812.155(3) for leasing equipment (trailer and hitch) from Sunbelt Rentals, failing to return the equipment, and failing to pay the overdue bill. I am requesting a warrant for W/M Christopher Hawkins DOB 01/18/85 for Felony Theft.
