The Person taken into custody ☒ committed the below acts in my presence. ☐ confessed to _____ ☐ was observed by _____ who told _____ that he/she saw the arrested person commit the below acts. ☐ was found to have committed the below acts, resulting from my (described) investigation. On the 19 day of October 2019 at 2120hrs ☐ A.M. ☒ P.M. (Specifically include facts constituting cause for arrest.) On the above stated date and time I was patrolling the Coral Sky Amphitheater located at 601-7 Sansbury Way West Palm Beach Fl. 33411 in unincorporated Palm Beach County. As I was exiting through the employee entrance/exit located off Sansbury Way I observed a Palm Beach County Fire Rescue ambulance with it's emergency lights on blocking the entrance/exit. I heard a Coral Sky employee say the fire rescue personnel needed assistance. Just as I heard the statement the side door to the ambulance flew open. I observed two Palm Beach County Fire Rescue personnel (later identified as Lt. Lazarus Rodriguez and Paramedic Caleb Heint) exit while struggling with an unknown white male (later identified as Christopher Sheridan). I heard them state they were assisting Christopher Sheridan's wife (later identified as Amanda Sheridan) but the unknown male kept violently trying to free himself from their grasp. I heard Christopher Sheridan state he wanted to help his wife but refused to listen to Palm Beach County Fire Rescue personnel. From what I heard and observed it appeared Christopher Sheridan was interfering with Palm Beach County Fire Rescue personnel as they were treating a patient. It appeared if Christopher Sheridan was to free himself he would continue to interfere and possibly cause harm to Palm Beach County Fire Rescue Personnel which in turn could harm the patient. I approached all three as they continued to struggle and identified myself as a Sheriff's Deputy. I informed Christopher Sheridan to stop his resistance and he was under arrest. He initially complied and I placed him into handcuffs. Shortly after placing him into handcuffs he became argumentative stating I have no heart and he wanted to help his wife. During this time we were directly next to the ambulance that was in the roadway. I told Christopher Sheridan we were going to walk to the side of the roadway. He initially refused but as I began to walk he pulled away which made me physically escort him to the side of the road. When we reached the side of the road I asked him to sit down which he refused. He continued to be verbally argumentative so I asked him at least two additional times to sit down and warned him if he refused to sit down I would place him on the ground. He refused each time and became increasingly belligerent each time. Based on him continuing to refuse to sit down and increasing his resistance I used a leg sweep to place him to the ground. As he reached the ground I controlled his body and placed my knee on his upper back. I told him to calm down and once he calmed down I would sit him up. After a few minutes he complied and was sat back up. I made contact with Palm Beach County Fire Rescue and asked if they wanted to prosecute which they stated they would not. Based on my investigation I find Probable Cause to Charge Christopher Sheridan with One Count of Resist Arrest Without Violence F.S.S. 843.02.
