


On Friday, May 18, 2018 at approximately 0146 hours I was asked to respond to a traffic stop at Jupiter Landings Dr/Roebuck Rd, Jupiter FL, 33458.

Upon arrival Sgt Bujnowski ID214 told me that he observed the vehicle, a red older model pickup truck bearing FL tag #815PJU, leave the east side of Jupiter West Plaza. Uncle Micks Bar is on east side of the plaza and is a very popular bar for local Jupiter residents. Sgt Bujnowski told me that he noticed that the pickup truck had a broken head light. Sgt Bujnowski said he performed traffic stop on the vehicle and they came to a stop on Jupiter Landings Dr just south of Roebuck Rd. Sgt Bujnowski went on to say that he approached the driver side window and detected an odor of an unknown alcoholic substance coming from inside the vehicle. I was then asked by Sgt Bujnowski to respond to the traffic stop to investigate a possible DUI.

I arrived on scene and approached the driver side window. I asked the driver, identified via FL DL as Christopher R Biggins (W/M 06/09/1988), where they were coming and he told me from "Micks", referring to Uncle Micks Bar in Jupiter West Plaza. Biggins told me that he only went to pick up his friend to drive him home. I asked Biggins if he was out anywhere else or coming from his residence, Biggins ignored me and kept staring straight ahead. Biggins became confrontational and would challenge some questions I asked him. At this time I had Biggins step out of the vehicle so I could speak with him. Biggins appeared unsteady on his feet as he walked to the back of the vehicle. I asked Biggins again how he ended up with his friend's vehicle. I did not understand how Biggins arrived at Uncle Micks to help his friend. Biggins became agitated as I asked him questions so I could understand what he was explaining. Once I understood what he was explaining I asked Biggins if he said that he lived at Caloosahatchee. I believed that I miss understood him when he told me where he resided. Biggins began to tell me "Stop it" repeatedly interrupting me when I tried to speak.

I then explained to Biggins that I would like him to perform some roadside tasks due to the fact that I suspected that he was under the influence and was not fit to drive. Biggins ignored what I said and stared away towards the lights of the police vehicle. I asked Biggins again if he would be willing to perform the tasks and he became more agitated. Biggins refused to do "anything". Biggins was placed under arrest for DUI. Biggins was put into handcuffs, checking for proper spacing and double locking.

I then transported Biggins to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20 minute observation period to ensure that Biggins did not take anything by mouth or regurgitate. I then requested Biggins provide a sample of his breath. He refused. I read Biggins his Miranda warnings from a prepared text. Biggins invoked his rights. I subsequently booked Biggins into the Palm Beach County Jail where I charged him with DUI per FSS 316.193(1).


