D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 27 DAY OF June 20 17, AT 2206 AM PM

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
I observed a Silver Dodge pickup truck bearing FL Tag #I811YK driving west on W. Indiantown Rd in the area of Riverbend Park. The truck was traveling in the right lane and crossed over the solid white line on the right side of the roadway multiple times and the truck jerked back into the travel lane. At this time I advised Northcom that I would be conducting a traffic stop on the truck. I activated my red and blue overhead emergency lights to signal the truck to pull over. The truck continued past Jupiter Farms Rd and made a right into the natural area just to the west of Jupiter Farms Rd. The driver and sole occupant of the vehicle, who was later positively identified as W/M Christopher B. Wolfe (6-13-64), slowed the vehicle to a stop and immediately opened the drivers door. I exited my fully marked Jupiter Police issued vehicle and approached the drivers window. I identified myself as Ofc. Fandrey with the Jupiter Police Department and advised Wolfe I stopped him for failure to maintain lane.

OBSERVATION OF DRIVER:

Wolfe had red bloodshot glassy eyes and there was a strong odor of an unknown alcoholic beverage coming from his person. Wolfe continually looked away from me while seated in the drivers seat and attempted to avoid eye contact. Wolfe had slightly slurred speech and continually repeated statements throughout the encounter. Located in the back seat floorboard there was an open brown "Budweiser" bottle containing an unknown alcoholic beverage that was laying on its side. The floorboard directly in front of the open end of the bottle appeared to be wet and the bottle was cold to the touch and had condensation on it. While speaking with Wolfe the odor of an unknown alcoholic beverage grew stronger. Wolfe was swaying while standing still and continually moved his feet in an effort to maintain his balance. Wolfe also continually moved his arms and could not stand still.

DRIVER'S STATEMENTS:

Wolfe stated that he had a beer earlier in the day as he was out all day wake boarding. Wolfe stated that he was probably using his phone which would explain why he was swerving. Wolfe was asked on a scale of 1-10 with 1 being completely sober and 10 being the most drunk he thought he was in his life Wolfe stated a 1. When asked about the beer bottle in the back floor board Wolfe said that he didn't know how the beer bottle ended up on the floor. Wolfe became upset throughout the encounter and stated several time that he did nothing wrong.

ODORS:

Odor of an unknown alcoholic beverage coming from his person. The odor grew stronger as I spoke with Wolfe.

SPEECH: **Mumbled, slurred, upset, repetitive, angry**

ATTITUDE: **Upset, emotional, angry at the situation, unsure of what to do, confused**

CLOTHING: **Blue shirt, brown shorts, brown slides**

WALK & TURN

Wolfe did not maintain the starting position through the instruction and demonstration phase. Wolfe had to be explained the instructions several times as he continually moved around. Wolfe stated he understood the instructions but was unsure if he wanted to do the tasks. Wolfe was explained his Taylor Warnings and again asked if he wished to complete the tasks, to which he eventually stated that he would continue the tasks. Wolfe stated "Im really not drunk." Wolfe was again explained the instructions and stated that it was hard to maintain the starting position. I explained to Wolfe that I was standing in the same position. Wolfe then again became unsure of what he wanted to do but eventually stated he would continue. Wolfe began early. Wolfe asked if I wanted him to go backwards to which I told him no and offered to re-demonstrate the task to which Wolfe stated "no". Wolfe began and stopped and then restarted. Wolfe did not count out loud and missed heel to toe several times and conducted the incorrect amount of steps. Wolfe was again explained the instructions. Wolfe missed heel to toe on 2,4,8, and did not turn around correctly. Missed heel to toe on 2,3,4,5,6,7,8,9 and used arms to balance.

ONE LEG STAND:

Wolfe did not maintain the starting position. Wolfe lifted his right leg but did not keep his legs straight. Wolfe utilized his arms to balance and continually swayed throughout the whole task.

FINGER TO NOSE:

Jackson did not maintain the starting position. Wolfe stated he knew his left from his right. Wolfe asked why he had to go through all of this and I stated it was voluntary and asked if he wished to continue to which he agreed. Wolfe began early. Missed first right but otherwise completed the task.

ROMBERG ALPHABET:

Wolfe could not maintain starting position and opened his eyes throughout the task. Wolfe stated "a,b,c,d,e,f,g,h,i,j,k,l,m,n,o,p,q,r,s,t,u,z". Wolfe asked if it was bad that he could not complete the ABCs. Wolfe was asked if he knew 1-100 and stated he did. Wolfe was asked to say 60-30 backwards. Wolfe stated "60,59,58,57,56,55,54,53,52,51,50,49,48,47,46,45,44,43,42,41,40,39,38,37,36,35,see,34,33,32,31,30,29,
