In the State Of Florida, County of Palm Beach, City of Boynton Beach, I, Officer Nalerio with the Boynton Beach Police Department responded to Chevron at 217 N Federal Highway in reference to Officer Jennings (ID 1000) being flagged down by a w/m and a w/f who appeared to be involved in a verbal argument. I proceeded to make contact with w/f Christy Han, who appeared to be intoxicated. Han's speech was slurred and I could smell a strong odor of alcohol every time she spoke. I was attempting to get Han's side of the story, but it was difficult as she kept yelling obscenities and wouldn't talk about why she was in an argument. It should be noted that Han was yelling obscenities and gathered a crowd from her actions. Han just stated that she wanted to go home, but couldn't provide me with an address to her residence or had any transportation. Since I couldn't get information from Han I asked her to sit in front of my vehicle, where the push bar is located. I then made my way to speak to the other involving party, Nabil Alkhafab. Alkhafab advised that while he was at El Camino, which is a restaurant that serves alcoholic beverages in Delray Beach, Han approached him and asked him for a ride to her house. Alkhafab agreed to give her a ride and proceeded to have her sit in the front passenger seat of his Black Mercedes Benz bearing FL tag G1XB18. Alkhafab advised that he traveled North on Federal Hwy from Delray Beach, until Han started to act disorderly in his vehicle. Alkhafab advised that she started kicking his passenger door and started to open the door to his vehicle. Being afraid that she was going to get hurt Alkhafab stopped at the Chevron gas station at 217 N Federal Hwy in Boynton Beach. At that point, Alkhafab advised that she refused to get out of his vehicle and that's when they both started to argue.

As Officer Jennings was patrolling the nearby area, he was flagged down by both subject. After getting Alkhafab's side of the story, I proceeded towards Han's location where she was then sitting on the hood of my vehicle, where she was not instructed to sit. I then proceeded to ask Han numerous times to get off the hood and speak to me. Han refused to get off the hood and continued yelling obscenities towards officers. I then advised Han that she could be subject to arrest for her disorderly actions. I grabbed Hans wrist to attempt to assist her off the hood of my vehicle and she flailed her arm and resisted my efforts. I asked Han one more time or she would be arrested, which she refused to listen to my commands. At that point, myself and officer Jennings struggled with Han to put the handcuffs on her wrist. I proceeded to place Han in Officer Jennings vehicle to continue my investigation. Shortly after, I heard a loud bang coming from Jennings police vehicle. I opened the door and observed Han kicking the vehicles window. Once the door was opened to attempt to calm Han down, she started to swing her legs out of the vehicle, and refused to place her legs back in the vehicle. At which point, myself and Officer Jennings grabbed her legs to attempt and place her legs back in the vehicle. In the process of doing so, Han repeatedly swung her legs and started to kick towards officers direction. It should be noted that myself and officer Jennings were struck in the chest area multiple times by Hans feet in the process of attempting to safely place her feet inside the vehicle. Once Han was safely secured in the vehicle, she was transported to Bethesda for medical clearance.



After being medically cleared she was transported to BBPD booking for further processing by Officer. Barrios (ID 984). It should be noted that while in booking area Han kept yelling obscenities and struggling with officers. At which point, Han kicked officer Barrios in the left thigh area.

Based on the above, I find Probable Cause to charge Han with (1) count of Disorderly Intoxication and (3) counts of Battery on a Law Enforcement Officer and (1) count of Resisting w/out violence. Han was transported to Palm Beach County Jail for further processing.
