I was conducting foot patrol within the Coral Sky Amphitheater, 601 Sansbury Way, West Palm Beach, FL 33411, during the course of a musical concert event.

During the course of my patrol, I was approached by employee personnel for the organization "LiveNation" in regards to a White Female subject whom was causing a public disturbance at a liquor bar on the South side of the Amphitheater. Employee personnel inquire if I may approach the female subject, later identified as W/F Cindy Chlodo, through Florida DHSMV records, and ask her to leave the premises due to her belligerent behavior. They advised she had consumed alcohol and was acting aggressive towards and verbally threatened employee personnel at the venue.

I then approached Chlodo, whom was standing at the liquor bar, and could immediately smell the strong odor of an alcoholic beverage emanating from her breath. Chlodo exhibited slurred speech and possessed redness to her eyes. She exhibited symptoms correlated to being intoxicated and under the influence of an alcoholic beverage. I then asked Chlodo if she may leave the premises under the authorization and instruction of employee personnel for the Coral Sky Amphitheater. Chlodo proceed to ignore me and then utilized verbal profanity towards myself and refused to leave the premises. I then asked her for her personal information for identify verification and she proceeded to be verbally defiant and caused a public disturbance within the venue by yelling profanity.



Supervisor personnel for the LiveNation organization and representatives for the Coral Sky Amphitheater, instructed Chlodo to leave the premises and she physically refused to do so and remained on the premises. I and additional Deputy Sheriff units then attempted to physically escort Chlodo off the premises of the Coral Sky Amphitheater. During the course of escorting W/F Cindy Chlodo, she actively resisted by physically pulling herself away from myself and additional units. She yelled profanity and obscenities within the Amphitheater and proceeded to cause a public disturbance within the venue. Chlodo then physically kicked Deputy Vandermeeren Sanchez, Id no. 31284 multiple times. Due to her physical resistance and belligerent behavior, I and additional units then physically gained control of W/F Cindy Chlodo, and applied handcuffs to her wrists (checked for proper fit and double locked).

Based on the provided information and W/F Cindy Chlodo's behavior and conduct, I have established probable cause and found W/F Cindy Chlodo, to be in violation of F.S.S. 856.011 on ONE (1) count, 810.09 (2)(b) on ONE (1) count, and 877.03 on ONE (1) count.

W/F Cindy Chlodo, was intoxicated and drank an alcoholic beverage in a public place and caused a public disturbance, contrary to Florida Statute 856.011(1). W/F Cindy Chlodo did commit such acts as are of a nature to corrupt the public morals or outrage the sense of public decency and engaged in conduct constituting a breach of the peace or disorderly conduct, contrary to Florida Statute 877.03. W/F Cindy Chlodo did unlawfully, without being authorized, licensed, or invited willfully enter upon or remain in any property other than a structure or conveyance the property of the Coral Sky Amphitheater, 601 Sansbury Way, West Palm Beach, FL 33411 as to which notice against entering or remaining was given, either by actual communication as described in 810.011, and did defy an order to leave, personally communicated to the offender by the owner of the premises or by an authorized person, contrary to Florida Statute 810.09 (2)(b).
