PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was driving eastbound on Lake Avenue approaching S. F. St. in the City of Lake Worth when I observed headlights coming towards me from S. Dixie Hwy. As I continued driving eastbound, the unknown vehicle turned northbound onto N. H. St. I followed suit, and observed the same vehicle stopped just past the white stop bar, pausing in the road at the intersection of N. H. St. and Lucerne Ave. I pulled up behind the vehicle as the driver slowly made a left hand turn to go westbound on Lucerne Ave. The driver attempted to pull off onto the north side of the road, and I quickly activated the lights and siren on my patrol car, initiating a traffic stop on Lucerne Ave. just east of N. F. St. My in-car camera was also activated to capture the incident. The vehicle came to a complete stop. I approached from the passenger side, and observed a female driver staring straight ahead, unaware of my presence at her window. I knocked on the passenger window, startling the female. She rolled down the window, and I noticed her eyes appeared bloodshot and she had no shoes on. I identified myself, and advised the female I had pulled her over because she was driving the wrong way down Lake Avenue. The female, later identified by Florida driver's license as Cindy Noely Temaj-Lopez, stated that she knew she was driving the wrong way but was only trying to wait for her friend and accidentally made a wrong turn. While Cindy spoke, her words were slurred and I could smell the odor of an unknown alcoholic beverage emanating from within the vehicle.

## OBSERVATION OF DRIVER:

I asked Cindy where she was coming from, to which she replied "Sneakers", a well-known bar in Lake Worth, located at 331 N. Dixie Hwy. As she spoke, the odor became stronger and more pronounced. I asked Cindy where she was headed, to which she replied "I'm trying to find Lake Worth and Boutwell". I then asked her if she had anything to drink this evening. Cindy stated that "I'm not going to lie I did have two vodkas". I informed her that I could tell she was obviously impaired, and it was my job to determine how impaired she was. I asked Cindy if she would consent to roadside sobriety tests, to which she stated yes. I asked her to exit her vehicle and walk to the rear, when she suddenly started crying and repeating "please don't let them take my kids". I asked her again to exit the vehicle, and she continued crying about her children but cooperated with my request. I walked to the front of my patrol car with Cindy, noting that she was swaying from side to side and struggling to walk straight with me. I requested she stand in front of the push bumper while I adjusted my camera and turned off my front lights. I then asked Cindy if she had any physical ailments or injuries that would prevent her from completing any roadside tasks. She stated that she takes Zoloft for her depression, but does not have any other issues that would inhibit her ability to follow my instructions. Various times throughout this period, Cindy repeatedly broke down in tears, hysterically sobbing that she hates her husband and doesn't want to lose her children.

## DRIVER'S STATEMENTS:

Cindy stated that she had drank two vodkas while at Sneakers Bar. I asked her if she truly thought she should be behind the wheel of a vehicle, to which she replied "no, I should not". She asked if her friend could just drive her home, to which I advised was dependent on what my investigation determined. After informing her that she was under arrest for DUI, she continued hysterically crying that she was a horrible person who had made a bad decision and kept repeating multiple reasons as to why she was drinking tonight (her brother left today, she hates her husband, she doesn't want to lose her children). ## ODORS:

Strong odor of an unknown alcoholic beverage coming from the interior of the vehicle.

SPEECH: slurred and mumbled at time

ATTITUDE: various mood swings; cooperative but hysterical; yelling but then laughing at self for being arrested

CLOTHING: navy blue dress, black and brown sandals

MEDICAL/OTHER: Zoloft for depression



**Other Observations:**

Def had bloodshot eyes and swayed while standing. She had difficulty waiting to begin the tasks. She also did not have shoes on nor did she realize it until I pointed it out when she exited the vehicle.

**WALK & TURN:**

Def had trouble standing straight up and swayed unsteadily with each step. She used her hands for balance multiple times. Def failed to maintain heel-to-toe with her steps. She initially walked 15 steps before removing both feet off of the white line to turn around and walk back towards my vehicle. On her way back, she walked 11 more steps before I finally stopped the task.

**ONE LEG STAND:**

Def did not keep her leg straight out during the task but had it bent, in a position similar to the 'Captain Morgan pose'. Def was unable to count in a sequential order, repeating numbers (9, 14) and repeating sequences (7,8 and 14, 15). Def placed foot on the ground multiple times. Def was unable to keep her hands at her side, rather raising them slightly and tapping in the air with each number said out loud. Def struggled to know which numbers were next, scrunching her face to try to recall what came after the number she had just recited. Def swayed while completing task, and failed to keep her arms at her side but rather used them for balance multiple times.

**FINGER TO NOSE:**

Def failed to touch just the tip of her finger to the tip of her tongue. Repeatedly, she would place the pad of her finger on either her face surrounding her nose, the tip of her lip, or up her nostril. Twice def failed to immediately return her hand to her side. Def swayed while completing task.

**ROMBERG ALPHABET:**

Def was able to recite the entire alphabet, but did it in a rhythmical pattern with various pauses throughout as she had to think of what letter came next.


