<p>The following incident occurred in the City of Delray Beach, Palm Beach County, Florida.</p> <p>On 4/19/17, I was dispatched to 415 E Atlantic Ave (Morley) regarding a theft that just occurred. I arrived and met with employee Christine Reiss. Reiss advised a hispanic female just stole multiple items from the store and they confronted her. As they confronted her, she ran into 65 SE 5th Ave apartment D.</p> <p>Reiss filled out a DBPD Victim/Witness Sworn Statement stating the following: A female came into the store with a large baby stroller. The female was going through the store picking out clothes and grabbing certain items. Reiss took the ones she was interested in and placed them in the fitting room for the female. Reiss advised there was so many clothes to try on that they even kept some outside of the fitting room and would give them to her when she gave some clothes back. The female brought her baby stroller into the fitting room. The female was trying clothes on for about two hours according to Reiss. During this time they were handing clothes to the female and she was handing clothes back to employees. When the female was ready to check out she attempts to only buy a couple of items and Reiss notices the fitting room is empty. Reiss then observes a few wooden hangers located on the underneath storage of the baby stroller and as she is taking them out of the stroller she observes a sweater she believes is from the store. Reiss asked the female if she gave everything back from the fitting room and she said yes. The female then notices Reiss doing this and starts asking about sunglasses. Reiss believes it was to distract her. Reiss then started to become suspicious of the female and started to look for items that she personally brought into the fitting room for the female and can't find them anywhere. Reiss then goes to look under the baby stroller again and takes the sweater that she thought was from the store and it was from the store. She then confronts the female again and she starts leaving the store saying that she gave everything back. The female then ran from the store once she got outside and went into 65 SE 5th Ave apartment D which is only a half a block away from the store.</p>

<p>Another employee Katherine Gamarel advised while the female was in the front of the store buying a couple of items she checked the fitting room. Gamarel did not know of a theft at this time but checked the fitting room as it is their policy to check as soon as someone leaves the fitting room to try and detect thefts. Gamarel advised there was only a couple of items were left in the fitting room and they had security sensors on them. Other items that they could not locate did not have security sensors on them. She then confronted the female with Reiss and she ran away from the store.</p> <p>There was five items reported stolen for a total of \$1084.98. The female did purchase four items valued at \$682.66</p> <p>The entire incident was caught on video. It shows Reiss receiving all of clothing items and giving some back. However the ones that were reported stolen were never seen coming out of the fitting room. The video follows the female throughout the store all the way to the exit and never shows the female putting the reported missing clothes down anywhere.</p> <p>Employees searched the female on Facebook and located her as they already had her information from the credit card transaction. I then used that information and searched her on DAVID and located the suspect who was identified as Claudia Dbrot.</p> <p>I made contact with Dbrot who admitted to shopping at the store and spending the amount listed but denied taking anything that she did not pay for.</p> <p>Based on the above facts, probable cause exists to charge Claudia Dbrot with Shoplifting/Retail Theft Over \$300 contrary to F.S.S. 812.015(8).</p>
